## **AMENDMENT NO. 3**

# Dated September 14, 2020 to the Annual Information Form dated November 14, 2019, as amended by Amendment No. 1 dated January 15, 2020 and by Amendment No. 2 dated July 30, 2020 of

Scotia Private Emerging Markets Pool (Pinnacle Series, Series F, Series I and Series M units) Scotia Private Global Real Estate Pool (Pinnacle Series, Series F and Series I units) (collectively, the "**Funds**")

This Amendment No. 3 to the annual information form dated November 14, 2019, as amended by Amendment No. 1 dated January 15, 2020 and Amendment No. 2 dated July 30, 2020 (the "Annual Information Form") relating to the offering of the Funds, provides certain additional information relating to the Funds and the Annual Information Form should be read subject to this information. All references to page numbers in the Annual Information Form are to the version of the annual information form filed with the Canadian securities regulatory authorities on SEDAR on November 15, 2019. All capitalized terms have the same meaning as set forth in the Annual Information Form, unless otherwise specifically defined in this Amendment No. 3.

The amendments reflected in this Amendment No. 3 relate to a change to the sub-advisors of the Funds.

## APPOINTMENT OF NEW SUB-ADVISORS

1. Effective September 25, 2020, Scotia Private Global Real Estate Pool will no longer be subadvised by Macquarie Investment Management and will instead be sub-advised by MFS Investment Management Canada Limited.

Accordingly, effective September 25, 2020 the Annual Information Form is amended as follows:

- (a) On page 57, the paragraph relating to Macquarie Investment Management and the corresponding table listing the individuals providing advice to Scotia Private Global Real Estate Pool are deleted in their entirety;
- (b) On page 58, the following is inserted immediately below the paragraph and corresponding table relating to MetLife Investment Management, LLC:

"MFS Investment Management Canada Limited ("**MFS**"), Toronto, Ontario, is the portfolio advisor of Private Real Estate Pool. The individuals providing advice are as follows:

(d) On page 94, under the heading "Portfolio Advisor Changes", the following paragraph is added immediately before the first paragraph:

"Prior to September 25, 2020, Macquarie Investment Management (formerly Delaware Investment Advisers) was the portfolio advisor to Private Real Estate Pool."

2. Effective October 13, 2020, Scotia Private Emerging Markets Pool will no longer be sub-advised by LMCG Investments, LLC and will instead be sub-advised by Wellington Management Canada ULC.

Accordingly, effective October 13, 2020 the Annual Information Form is amended as follows:

- (a) On page 57, the paragraph relating to LMCG Investments and the corresponding table listing the individuals providing advice to Scotia Private Emerging Markets Pool are deleted in their entirety;
- (b) On page 61, the following is inserted immediately below the paragraph and corresponding table relating to Victory Capital Management:

"Wellington Management Canada ULC ("Wellington"), Toronto, Ontario, is the portfolio advisor of Emerging Markets Pool. The individuals providing advice are as follows:
