1832 Asset Management L.P. is the manager (the "Manager") of the fund. In this document, "we", "us", "our" and the "Manager" refer to 1832 Asset Management L.P. and the "Fund" refers to 1832 AM Emerging Markets Equity Pool.

The term "net asset value" or "net asset value per unit" in this document refers to the net asset value determined in accordance with Part 14 of National Instrument 81-106 – Investment Fund Continuous Disclosure ("National Instrument 81-106"); while the term "net assets" or "net assets per unit" refers to total equity or net assets attributable to unitholders of the Fund as determined in accordance with IFRS Accounting Standards.

Investment Objective and Strategies

The Fund's investment objective is to provide capital appreciation over the long term by investing primarily in equity securities of companies in emerging markets, directly or through investments in securities of other funds.

The Fund seeks to achieve its investment objective by constructing a portfolio of publicly traded equity securities of companies located in, or that have exposure to, emerging markets.

The portfolio advisers use a bottom-up, fundamental investment approach that seeks out high quality businesses with attractive earnings prospects at reasonable valuations; along with a growth-oriented investment approach designed to identify growing companies.

The Fund can invest up to 100% of its assets in foreign securities.

Risk

The risks associated with investing in the Fund are as described in the simplified prospectus. There were no material changes to the Fund over its last completed financial year that affected the overall level of risk of the Fund.

Results of Operations

For the year ended at December 31, 2024 (the "period"), the Series I units of the Fund generated a total return of 23.5%. Fund

returns are reported net of all management fees and expenses, unlike the returns of the Fund's benchmark, which is based on the performance of an index that does not pay fees or incur expenses.

The Fund's broad-based benchmark, the MSCI Emerging Markets Index (C\$) returned 17.0% during the same period. In accordance with National Instrument 81-106, we have included a comparison to this broad-based index to help you understand the Fund's performance relative to the general performance of the market.

The period was characterized by varying inflation trends across major economies, the evolving impact of emerging technologies including artificial intelligence ("AI"), ongoing geopolitical conflicts and trade pressures, potentially constrained U.S. labour supply and inconsistent global monetary and fiscal policies. Other important macroeconomic dynamics included movements in yield curves and the U.S. Treasury market, global credit conditions and the interplay between gross domestic product growth and inflation.

In the first quarter, emerging economies with strong internal growth dynamics delivered steady and consistent gains, while economies at the heart of the global semiconductor supply chain benefited from improved demand and a more positive outlook.

In the second quarter, the picture in emerging markets ("EM") remained largely positive despite divergent performance driven by election outcomes and sensitivity to the U.S. interest rate outlook.

Strong market momentum continued into the third quarter, with EM and key global indexes registering substantial gains. In September, the U.S. Federal Reserve Board reduced interest rates by 50 basis points. U.S. and Chinese policy measures boosted EM's economic outlook. Central banks in Indonesia and the Philippines began reducing their interest rates.

In the fourth quarter, expectations for easing U.S. monetary policy and bold stimulus measures from China created optimism. However, Donald Trump's election victory introduced uncertainty about future U.S. policy and raised concerns about global trade. While U.S. markets and the U.S. dollar rallied, EM and most international markets pared back gains, particularly countries with weaker currencies or significant exposure to U.S. exports. Chinese economic weakness was a key theme for EM owing to ongoing property sector challenges and restrained government stimulus. Latin America faced significant challenges, with key markets in Brazil and Mexico facing significant pressures.

The Fund outperformed the broad-based benchmark as a result of security selection.

The Fund's security selection within the Information Technology, Industrials, Communication Services and Consumer Discretionary sectors contributed to performance, as did its allocation to the Materials sector. The Fund's security selection within Brazil and South Korea also contributed, as did allocation to the U.S. Individual contributors included NVIDIA Corporation, which consistently outperformed expectations owing to robust demand for its AI-focused graphics processing units. Taiwan Semiconductor Manufacturing Company Limited benefited from AI-driven demand strength. Embraer SA's commercial aviation business operated under a favourable backdrop for order growth, pricing

power and margin improvement. Sea Limited, ADR delivered positive results with robust execution across its e-commerce, gaming and financial technology segments.

The Fund's security selection within the Financials, Consumer Discretionary, Health Care and Information Technology sectors detracted from performance. Security selection within India also detracted, as did allocation to China. Individual detractors included Alchip Technologies, Limited as its largest client transitioned to a competing design firm, at least temporarily. Samsung Electronics Co., Ltd. experienced slowing demand in its core memory business and lagged peers in the high-bandwidth memory segment.

New positions included Meituan, which reported better-than-expected first-quarter earnings as sales of its core food delivery business beat expectations. ICICI Bank Limited gained market share related to deposits and loan growth owing to its scale advantages. Polish retail company Dino Polska SA operates a unique model in the discount grocery space. The company owns most of its real estate and its scalable store deployment model creates industry-leading returns and paybacks. MercadoLibre, Inc. operates the largest e-commerce ecosystem in Latin America, benefiting from low e-commerce penetration in the region and the secular shift to digital financial services.

Increased positions included Meta Platforms, Inc. which demonstrated consistently strong growth in core advertising revenues. Tencent Holdings Limited benefited from encouraging first-quarter results, accelerating advertising revenue and cost-cutting initiatives. Several other positions were increased to take advantage of increasingly attractive valuations following share price weakness.

Decreased positions included Samsung Electronics Co., Ltd. and SK Hynix, Inc., as their shares had performed well, but both companies produced disappointing margins and provided cautious outlooks. Several other positions were trimmed to manage position sizes and country exposure.

Eliminated positions included Larsen & Toubro Limited, which performed well but generated disappointing margin levels and provided a cautious profit outlook. PT Bank Rakyat Indonesia (Persero) Tbk's key micro-lending business faced worse-than-expected challenges from non-performing loans. Ping An Insurance (Group) Company of China Ltd.'s eroding growth and return profiles showed limited signs of recovery.

The Fund's net asset value increased to \$371.8 million at December 31, 2024, from \$334.2 million at December 31, 2023. This change was composed of net redemptions of \$37.6 million, and investment performance of \$75.2 million. The investment performance of the Fund includes income and expenses which vary year over year. The Fund's income and expenses changed compared to the previous year mainly as a result of fluctuations in average net assets, portfolio activity and changes in the Fund's income earning investments.

The Fund may make distributions at a rate determined by the Manager from time to time. If the aggregate amount of distributions exceeds the portion of net income and net realized capital gains, the excess will constitute a return of capital. The Manager does not

believe that the return of capital distributions made by the Fund have a meaningful impact on the Fund's ability to implement its investment strategy or to fulfill its investment objective.

Recent Developments

There have been no recent developments that have affected, or are likely to materially affect the Fund.

Related Party Transactions

The Manager is a wholly-owned subsidiary of The Bank of Nova Scotia ("Scotiabank"). Scotiabank also owns, directly or indirectly, 100% of Scotia Securities Inc., a mutual fund dealer, and Scotia Capital Inc. (which includes ScotiaMcLeod and Scotia iTRADE), an investment dealer.

The Manager, on behalf of the Fund, may enter into transactions or arrangements with other members of Scotiabank or certain other companies that are related or connected to the Manager (each a "related party"). All transactions between the Fund and the related parties are in the normal course of business and are carried out at arm's length terms.

The purpose of this section is to provide a brief description of any transaction involving the Fund and a related party.

Fixed Administration Fees and Fund Costs

The Manager pays the operating expenses of the Fund, other than Fund Costs, in exchange for the payment by the Fund of a fixed rate administration fee (the "Fixed Administration Fee") to the Manager with respect to each series of the Fund. The expenses charged to the Fund in respect of the Fixed Administration Fee are disclosed in the Fund's financial statements. The Fixed Administration Fee is equal to a specified percentage of the net asset value of a series, calculated and paid in the same manner as the management fees for the Fund. Further details about the Fixed Administration Fee can be found in the Fund's most recent simplified prospectus.

In addition, each series of the Fund is responsible for its proportionate share of certain operating expenses ("Fund Costs"). Further details about Fund Costs can be found in the Fund's most recent simplified prospectus.

The Manager, at its sole discretion, may waive or absorb a portion of a series' expenses. These waivers or absorptions may be terminated at any time without notice.

Related Sub-Advisor

The Fund is sub-advised by Jarislowsky Fraser Limited, a related party to the fund. The Manager may pay a fee, which is negotiated with the sub-advisor, to the sub-advisor in respect of the investment advisory services provided to the Fund.

Other Fees

The Manager, or its affiliates, may earn fees and spreads in connection with various services provided to, or transactions with, the Fund, such as banking, custody, brokerage, foreign exchange or derivatives transactions. The Manager, or its affiliates, may earn

a foreign exchange spread when unitholders switch between series of funds denominated in different currencies.

Independent Review Committee

The Manager has established an independent review committee (the "IRC") in accordance with National Instrument 81-107 – Independent Review Committee for Investment Funds ("NI 81-107") with a mandate to review and provide recommendations or approval, as required, on conflict of interest matters referred to it by the Manager on behalf of the Fund. The IRC is responsible for overseeing the Manager's decisions in situations where the Manager is faced with any present or perceived conflicts of interest, all in accordance with NI 81-107.

The IRC may also approve certain mergers between the Fund and other funds, and any change of the auditor of the Fund. Subject to any corporate and securities law requirements, no securityholder approval will be obtained in such circumstances, but you will be sent a written notice at least 60 days before the effective date of any such transaction or change of auditor. In certain circumstances, securityholder approval may be required to approve certain mergers.

The IRC has five members, Stephen J. Griggs (Chair), Steven Donald, Heather A. T. Hunter, Cecilia Mo and Jennifer L. Witterick, each of whom is independent of the Manager.

The IRC prepares and files a report to the securityholders each fiscal year that describes the IRC and its activities for securityholders as well as contains a complete list of the standing instructions. These standing instructions enable the Manager to act in a particular conflict of interest matter on a continuing basis provided the Manager complies with its policies and procedures established to address that conflict of interest matter and reports periodically to the IRC on the matter. This report to the securityholders is available on the Manager's website or, at no cost, by contacting the Manager.

The compensation and other reasonable expenses of the IRC will be paid out of the assets of the Fund as well as out of the assets of the other investment funds for which the IRC may act as the independent review committee. Each member of the IRC receives an annual retainer of \$62,000 (\$77,000 for the Chair), plus expenses for each meeting. The fees and expenses, plus associated legal costs, are split equally among all of the funds managed by the Manager for which the IRC acts as the independent review committee. The main component of compensation is an annual retainer fee. Expenses of the IRC may include premiums for insurance coverage, travel expenses and reasonable out-of-pocket expenses.

The Manager, in respect of the Fund, received the following standing instructions from the IRC with respect to related party transactions:

- Paying brokerage commissions and spreads to a related party for effecting security transactions on an agency and principal basis on behalf of the Fund;
- Purchases or sales of securities of an issuer from or to another investment fund managed by the Manager;
- Investments in the securities of issuers for which a related underwriter acted as an underwriter during the distribution of

such securities and the 60-day period following the completion of such distribution;

- Executing foreign exchange transactions with a related party on behalf of the Fund;
- Purchases of securities of a related party;
- Entering into over-the-counter derivatives on behalf of the Fund with a related party;
- Outsourcing products and services to related parties which can be charged to the Fund;
- Acquisition of prohibited securities as defined by securities regulations;
- Trading in mortgages with a related party;
- Entering into a designated broker agreement with a related party; and
- Entering into a prime broker agreement with a related party.

The Manager is required to advise the IRC of any breach of a condition of the standing instructions. The standing instructions require, among other things, that the investment decision in respect to a related party transaction: (a) is made by the Manager free from any influence by an entity related to the Manager and without taking into account any consideration to any associate or affiliate of the Manager; (b) represents the business judgment of the Manager uninfluenced by considerations other than the best interests of the Fund; and (c) is made in compliance with the Manager's written policies and procedures. Transactions made by the Manager under the standing instructions are subsequently reviewed by the IRC to monitor compliance.

The Manager, in respect of the Fund, did not rely on IRC standing instructions regarding related party transactions during the period.

(4) The Fund's portfolio turnover rate indicates how actively the Fund's portfolio advisor manages its portfolio investments. The higher a fund's portfolio turnover rate in a period, the greater the trading costs payable by the fund in the period, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund.

Management Fee

The Manager is not entitled to a management fee payable by the Fund in respect of Series I units. The management fee is negotiable and paid by unitholders directly to the Manager.

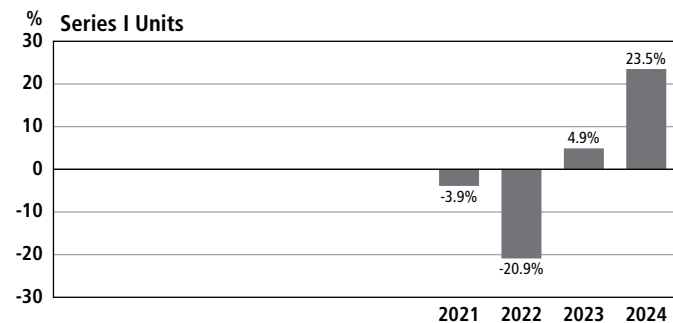
Past Performance
