1832 Asset Management L.P. is the manager (the "Manager") of the fund. In this document, "we", "us", "our" and the "Manager" refer to 1832 Asset Management L.P. and the "Fund" refers to 1832 AM Global Credit Pool.

The term "net asset value" or "net asset value per unit" in this document refers to the net asset value determined in accordance with Part 14 of National Instrument 81-106 – Investment Fund Continuous Disclosure ("National Instrument 81-106"); while the term "net assets" or "net assets per unit" refers to total equity or net assets attributable to unitholders of the Fund as determined in accordance with IFRS Accounting Standards.

Investment Objective and Strategies

The Fund's investment objective is to maximize current income and provide modest capital gains. It invests primarily in investment grade non-Canadian dollar corporate bonds diversified broadly across industries, issuers, and regions.

The Fund seeks to achieve its investment objective by investing the majority of its assets in a diversified portfolio of corporate fixed income securities of varying maturities.

In addition to corporate fixed income securities, the Fund may, but is not limited to, invest in sovereign, agency, and supranational securities, corporate issues below investment grade, securities and instruments issued or economically tied to emerging market countries, common or preferred stocks.

The Fund may use derivatives such as options, futures contracts, forwards and swaps, as permitted by Canadian securities laws to, among other things:

- hedge against declines in security prices, financial markets, exchange rates and interest rates;
- gain exposure to securities, financial markets and foreign currencies; and
- seek to obtain market exposure to securities in which it primarily invests by entering into a series of purchase and sale

contracts or by using other investment techniques such as buy backs and dollar rolls.

The Fund can invest up to 100% of its assets in foreign securities.

Risk

The risks associated with investing in the Fund are as described in the simplified prospectus. There were no material changes to the Fund over its last completed financial year that affected the overall level of risk of the Fund.

Results of Operations

For the year ended at December 31, 2024 (the "period"), the Series I units of the Fund generated a total return of 3.4%. Fund returns are reported net of all management fees and expenses, unlike the returns of the Fund's benchmark, which is based on the performance of an index that does not pay fees or incur expenses.

The Fund's broad-based benchmark, the Bloomberg U.S. Credit Index (C\$, Hedged), returned 9.9% during the same period. In accordance with National Instrument 81-106, we have included a comparison to this broad-based index to help you understand the Fund's performance relative to the general performance of the market, but caution that the Fund's mandate may be significantly different from the indices shown.

The Fund's blended benchmark, 40% Bloomberg U.S. Aggregate Bond Index (C\$, Hedged) and 60% Bloomberg U.S. Credit Index (C\$, Hedged), returned 5.9% during the same period. We have included this comparison, which more closely reflects the market sectors and/or asset classes in which the Fund invests, to provide a more useful comparative to the performance of the Fund.

Early in the period, investors were anticipating multiple interest rate cuts by the world's major central banks, starting as early as March. However, stronger-than-expected economic growth and a more gradual decline in global inflation pushed expectations back, leading to lower bond prices.

Bonds rallied sharply in the third quarter as central banks like the U.S. Federal Reserve Board ("Fed"), Bank of Canada, Bank of England and European Central Bank began lowering interest rates to support labour markets and growth. However, the Reserve Bank of Australia and Bank of Japan held interest rates steady. Although central banks continued to cut interest rates during the fourth quarter, bonds sold off again amid anticipated economic policy changes by the new U.S. presidential administration and geopolitical upheaval in Canada, France, Germany and South Korea.

During the fourth quarter, U.S. nonfarm payroll jobs growth strengthened, with the three-month average pace increasing to 173,000 per month in November. Consequently, the unemployment rate has remained constant at approximately 4.2% in the U.S.

In terms of inflation, the U.S. core Personal Consumption Expenditures Price Index increased at an average monthly rate of 0.19%, consistent with the Fed's target-implied monthly rate.

For the period, global bond yields were broadly higher, though the degree varied from country to country. Regionally, bond markets

in the Asia-Pacific region were the best performers, while the U.S. market lagged. On a sector basis, corporate bonds outperformed sovereign government securities, led by the high-yield sector.

The Fund underperformed its blended benchmark, primarily as a result of security selection.

The Fund's country allocation detracted from performance from a factor perspective. The Fund's security selection within emerging markets also detracted. The Fund's security selection within U.S. Treasury bonds detracted from performance, as did its overweight exposure to and security selection within agency mortgage-backed securities. Individual detractors included the Fund's lack of exposure to the eurozone, its overweight exposure to the U.S. and its lack of exposure to China. Other detractors included Warner Bros. Discovery, Inc. (5.05%, 15/03/2042), Gray Media Inc. (7%, 15/05/2027) and Comcast Corp. (5.35%, 15/05/2053).

From a factor perspective, the Fund's security selection was the largest contributor to performance, particularly in the Energy and Financials sectors. Security selection within developed-market investment-grade corporate bonds contributed to performance as well, particularly within insurance, banking and transportation companies. The Fund's allocations within energy, banking and finance industries also contributed. The Fund's duration (interest rate sensitivity) and yield curve management contributed to performance, including a short position in Japan. The Fund's currency management also contributed to performance. The Fund's shorter duration in U.S. holdings contributed as yields moved higher and U.S.-dollar exposure was beneficial as it appreciated relative to the Canadian dollar. Individual contributors included an overweight exposure to American Airlines Group Inc. (3.15%, 15/8/2033), as well as Pacific Life Insurance Company (4.3%, 24/10/2067) and Consensus Cloud Solutions Inc. (6.5%, 15/10/2028), which performed well as spreads have narrowed significantly since February.

New positions included securitized bonds given a strengthening outlook for the asset class and their relative value over investmentgrade corporate bonds.

Increased positions included high-yield bonds owing to their more positive outlook.

Decreased positions included Treasury bonds and cash on hand, which was used to purchase securitized bonds.

The Fund's net asset value decreased to \$917.7 million at December 31, 2024, from \$942.7 million at December 31, 2023. This change was composed of net redemptions of \$55.9 million, and investment performance of \$30.9 million. The investment performance of the Fund includes income and expenses which vary year over year. The Fund's income and expenses changed compared to the previous year mainly as a result of fluctuations in average net assets, portfolio activity and changes in the Fund's income earning investments.

The Fund may make distributions at a rate determined by the Manager from time to time. If the aggregate amount of distributions exceeds the portion of net income and net realized capital gains, the excess will constitute a return of capital. The Manager does not believe that the return of capital distributions made by the Fund have a meaningful impact on the Fund's ability to implement its investment strategy or to fulfill its investment objective.

Recent Developments

Risk Rating Change

Effective May 31, 2024, the risk rating of the Fund has been changed from Low to Low to Medium. This change is in accordance with the Risk Classification Methodology mandated by the Canadian Securities Administrators. There are no changes to the investment objective or strategies of the Fund associated with the new risk rating.

Sub-Adviser Change

Effective January 24, 2024, Manulife Asset Management (US) LLC And Payden & Rygel Assumed The Role Of Portfolio Adviser Replacing PIMCO Canada Corp.

Related Party Transactions

The Manager is a wholly-owned subsidiary of The Bank of Nova Scotia ("Scotiabank"). Scotiabank also owns, directly or indirectly, 100% of Scotia Securities Inc., a mutual fund dealer, and Scotia Capital Inc. (which includes ScotiaMcLeod and Scotia iTRADE), an investment dealer.

The Manager, on behalf of the Fund, may enter into transactions or arrangements with other members of Scotiabank or certain other companies that are related or connected to the Manager (each a "related party"). All transactions between the Fund and the related parties are in the normal course of business and are carried out at arm's length terms.

The purpose of this section is to provide a brief description of any transaction involving the Fund and a related party.

Fixed Administration Fees and Fund Costs

The Manager pays the operating expenses of the Fund, other than Fund Costs, in exchange for the payment by the Fund of a fixed rate administration fee (the "Fixed Administration Fee") to the Manager with respect to each series of the Fund. The expenses charged to the Fund in respect of the Fixed Administration Fee are disclosed in the Fund's financial statements. The Fixed Administration Fee is equal to a specified percentage of the net asset value of a series, calculated and paid in the same manner as the management fees for the Fund. Further details about the Fixed Administration Fee can be found in the Fund's most recent simplified prospectus.

In addition, each series of the Fund is responsible for its proportionate share of certain operating expenses ("Fund Costs"). Further details about Fund Costs can be found in the Fund's most recent simplified prospectus.

The Manager, at its sole discretion, may waive or absorb a portion of a series' expenses. These waivers or absorptions may be terminated at any time without notice.

Other Fees

The Manager, or its affiliates, may earn fees and spreads in connection with various services provided to, or transactions with, the Fund, such as banking, custody, brokerage, foreign exchange or derivatives transactions. The Manager, or its affiliates, may earn a foreign exchange spread when unitholders switch between series of funds denominated in different currencies.

Independent Review Committee

The Manager has established an independent review committee (the "IRC") in accordance with National Instrument 81-107 – Independent Review Committee for Investment Funds ("NI 81-107") with a mandate to review and provide recommendations or approval, as required, on conflict of interest matters referred to it by the Manager on behalf of the Fund. The IRC is responsible for overseeing the Manager's decisions in situations where the Manager is faced with any present or perceived conflicts of interest, all in accordance with NI 81-107.

The IRC may also approve certain mergers between the Fund and other funds, and any change of the auditor of the Fund. Subject to any corporate and securities law requirements, no securityholder approval will be obtained in such circumstances, but you will be sent a written notice at least 60 days before the effective date of any such transaction or change of auditor. In certain circumstances, securityholder approval may be required to approve certain mergers.

The IRC has five members, Stephen J. Griggs (Chair), Steven Donald, Heather A. T. Hunter, Cecilia Mo and Jennifer L. Witterick, each of whom is independent of the Manager.

The IRC prepares and files a report to the securityholders each fiscal year that describes the IRC and its activities for securityholders as well as contains a complete list of the standing instructions. These standing instructions enable the Manager to act in a particular conflict of interest matter on a continuing basis provided the Manager complies with its policies and procedures established to address that conflict of interest matter and reports periodically to the IRC on the matter. This report to the securityholders is available on the Manager's website or, at no cost, by contacting the Manager.

The compensation and other reasonable expenses of the IRC will be paid out of the assets of the Fund as well as out of the assets of the other investment funds for which the IRC may act as the independent review committee. Each member of the IRC receives an annual retainer of \$62,000 (\$77,000 for the Chair), plus expenses for each meeting. The fees and expenses, plus associated legal costs, are split equally among all of the funds managed by the Manager for which the IRC acts as the independent review committee. The main component of compensation is an annual retainer fee. Expenses of the IRC may include premiums for insurance coverage, travel expenses and reasonable out-ofpocket expenses.

The Manager, in respect of the Fund, received the following standing instructions from the IRC with respect to related party transactions:

- Paying brokerage commissions and spreads to a related party for effecting security transactions on an agency and principal basis on behalf of the Fund;
- Purchases or sales of securities of an issuer from or to another investment fund managed by the Manager;
- Investments in the securities of issuers for which a related underwriter acted as an underwriter during the distribution of such securities and the 60-day period following the completion of such distribution;
- Executing foreign exchange transactions with a related party on behalf of the Fund;
- Purchases of securities of a related party;
- Entering into over-the-counter derivatives on behalf of the Fund with a related party;
- Outsourcing products and services to related parties which can be charged to the Fund;
- Acquisition of prohibited securities as defined by securities regulations;

• Trading in mortgages with a related party;

- Entering into a designated broker agreement with a related party; and
- Entering into a prime broker agreement with a related party.

The Manager is required to advise the IRC of any breach of a condition of the standing instructions. The standing instructions require, among other things, that the investment decision in respect to a related party transaction: (a) is made by the Manager free from any influence by an entity related to the Manager and without taking into account any consideration to any associate or affiliate of the Manager; (b) represents the business judgment of the Manager uninfluenced by considerations other than the best interests of the Fund; and (c) is made in compliance with the Manager's written policies and procedures. Transactions made by the Manager under the standing instructions are subsequently reviewed by the IRC to monitor compliance.

The Manager, in respect of the Fund, did not rely on IRC standing instructions regarding related party transactions during the period.

The following tables show selected key financial information about each series of the Fund and are intended to help you understand the Fund's financial performance for the periods indicated. The information on the following tables is based on prescribed regulations and as a result, is not expected to add across due to the increase (decrease) in net assets from operations being based on average units outstanding during the period and all other numbers being based on actual units outstanding at the relevant point in time. Footnotes for the tables are found at the end of the Financial Highlights section.

- (2) The management expense ratio is based on the total expenses (including sales tax, and excluding commissions and other portfolio transaction costs) of each series of the Fund and a proportional share of underlying funds' expenses (mutual funds, ETFs and closed-end funds), where applicable, for the stated period and is expressed as an annualized percentage of daily average net asset value during the period.
- (3) The trading expense ratio represents total commissions and other portfolio transaction costs, short borrowing costs and interest on leverage of the Fund and the underlying funds, where applicable, expressed as an annualized percentage of daily average net asset value of the Fund during the period.
- (4) The Fund's portfolio turnover rate indicates how actively the Fund's portfolio advisor manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the period. The higher a fund's portfolio turnover rate in a period, the greater the trading costs payable by the fund in the period, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund.

Management Fee


The Manager is not entitled to a management fee payable by the Fund in respect of Series I units. The management fee is negotiable and paid by unitholders directly to the Manager.

Past Performance

The information shown assumes that all distributions made by each series of the Fund in the periods shown were reinvested in additional units of the relevant series. In addition, the information does not take into account sales, redemption, distribution or other optional charges that would have reduced returns or performance.

Index Descriptions

Bloomberg U.S. Credit Index (C\$, Hedged) – This index measures the investment grade, U.S. dollar denominated, fixed rate, taxable corporate and government-related bond markets. It is composed of the U.S. Corporate Index and a non-corporate component that includes non-U.S. agencies, sovereigns, supranationals and local authorities.

Bloomberg U.S. Aggregate Bond Index (C\$, Hedged) – This is a broad-based index that measures the investment grade, U.S. dollardenominated fixed-rate taxable bond market. The index includes treasuries, government-related and corporate securities, mortgage backed securities, asset backed securities and commercial mortgage backed securities.
