1832 Asset Management L.P. is the manager (the "Manager") of the fund. In this document, "we", "us", "our" and the "Manager" refer to 1832 Asset Management L.P. and the "Fund" refers to 1832 AM International Equity LP.

The term "net asset value" or "net asset value per unit" in this document refers to the net asset value determined in accordance with Part 14 of National Instrument 81-106 – Investment Fund Continuous Disclosure ("National Instrument 81-106"); while the term "net assets" or "net assets per unit" refers to total equity or net assets attributable to unitholders of the Fund as determined in accordance with International Financial Reporting Standards ("IFRS").

Investment Objective and Strategies

The Fund's investment objective is to achieve long-term capital growth. It invests primarily in equity securities of companies located outside of Canada and the U.S.

The portfolio sub-advisor applies a fundamental bottom-up investment approach to seek out companies located outside of Canada and the U.S. that are trading at sensible valuations, are viewed to be of high quality, and have strong financials and sustainable growth potential.

The Fund can invest up to 100% of its assets in foreign securities.

Risk

The risks associated with investing in the Fund are as described in the simplified prospectus. There were no material changes to the Fund over its last completed financial year that affected the overall level of risk of the Fund.

Results of Operations

For the year ended December 31, 2022 (the "period"), the Series I units of the Fund generated a total return of – 16.1%. Fund returns are reported net of all management fees and expenses, unlike the returns of the Fund's benchmark, which is based on the performance of an index that does not pay fees or incur expenses.

The Fund's broad-based benchmark, the MSCI EAFE Index (C\$), returned -8.5% during the same period. In accordance with National Instrument 81-106, we have included a comparison to this broad-based index to help you understand the Fund's performance relative to the general performance of the market.

Over the period, the global macroeconomic backdrop was dominated by growing concerns about an economic downturn amid persistently higher inflation. Rising interest rates amplified these concerns, while also contributing to an equity market rotation away from growth stocks and toward value stocks. The Russia-Ukraine conflict further fuelled inflationary pressures and markets grew increasingly worried about the potential for a deep recession in Europe. However, energy prices began to moderate later in the period, and a less severe slowdown was expected.

Elsewhere, the removal of pandemic-driven lockdowns in China was taken as positive news but was followed by a sharp increase in COVID-19 cases in the country, with the potential to hinder the economic recovery. By the end of the period, inflation had begun to slow but remained elevated, and central banks continued to increase interest rates in response.

The Fund underperformed the broad-based benchmark as result of stock selection in Japan and Europe (excluding the U.K.), as well as in the Health Care and Industrials sectors.

Top individual detractors from the Fund's performance included an overweight holding in Sysmex Corp., an in-vitro diagnostics company that was impacted by the shift from growth stocks to value. While Sysmex has been affected by COVID-19 outbreaks in China, the company's operating performance has improved with signs of economic recovery in China showing. An overweight holding in Adidas AG and a position in Taiwan Semiconductor Manufacturing Co. Ltd. detracted from performance. Adidas reduced its earnings guidance three times, with China remaining the consistent factor behind the downgrades, and the unwinding of the Yeezy partnership also having an impact. Shares of Taiwan Semiconductor fell as a result of a valuation compression in the Information Technology sector and geopolitical concerns.

The Fund's slightly overweight exposure to Canada contributed to performance, as did stock selection in the Real Estate sector. Individual contributors to performance included an overweight holding in Novo Nordisk AS and a position in Alimentation Couche-Tard Inc. Novo Nordisk continues to benefit from sales of its GLP1 products, while its new obesity drug continues to capture market attention. Alimentation Couche-Tard is gaining market share in other retail categories as a result of its proximity benefits, faster transaction speeds, extended opening hours and one-stop-shop offerings. In addition, an overweight holding in AIA Group Ltd. contributed to performance as its growth momentum is returning post-pandemic, while the relaxation of lockdowns in China and Hong Kong is supporting investor sentiment.

During the period, Shimadzu Corp., OBIC Co. Ltd. and Atlas Copco AB were added to the Fund. Shimadzu helps customers across industries detect and measure the constituent components of their products, which is becoming increasingly important for industries facing rising regulatory and health standards. By

successfully growing sales of more-profitable products, Shimadzu should continue to improve long-term profitability. OBIC operates in the enterprise resource planning software market for small and medium-sized enterprises in Japan. Structural growth in information technology investment across corporate Japan, as well as in cloud software, should translate to continued long-term growth. Atlas Copco provides sustainable productivity solutions, including industrial compressors and vacuums, to a range of industries. Atlas has an attractive growth profile and aims to grow revenues by 8% per year through the cycle.

The Fund's holdings in Smith & Nephew PLC, Givaudan SA and Makita Corp. were exited. Smith & Nephew was sold after another unexpected management departure. There have been three CEOs at Smith & Nephew in five years, which has prompted concerns over the company's ability to execute in a challenging operating environment. The market leader in the fragrance and flavour industry, Givaudan has acquired several businesses to bolster its presence in natural flavours and ingredients, resulting in a lower return structure and a higher level of debt on its balance sheet. Japanese power tool maker Makita faces a challenging operating landscape in Europe and tough promotional conditions in the U.S. Furthermore, supply chain issues have forced Makita to spend its cash balance to secure inventory, weakening its balance sheet and making a dividend decrease more likely.

The Fund's net asset value decreased to \$487.4 million at December 31, 2022, from \$645.6 million at December 31, 2021. This change was composed of investment performance of negative \$104.1 million and net redemptions of \$54.1 million. The investment performance of the Fund includes income and expenses which vary year over year. The Fund's income and expenses changed compared to the previous year mainly as a result of fluctuations in average net assets, portfolio activity and changes in the Fund's income earning investments.

Recent Developments

Risk Rating change

Effective January 20, 2022, the risk rating of the Fund has been changed from Medium to High to Medium. This change is in accordance with the Risk Classification Methodology mandated by the Canadian Securities Administrators. There are no changes to the investment objective or strategies of the Fund associated with the new risk rating.

Related Party Transactions

The Manager is a wholly-owned subsidiary of The Bank of Nova Scotia ("Scotiabank"). Scotiabank also owns, directly or indirectly, 100% of Scotia Securities Inc., a mutual fund dealer, and Scotia Capital Inc. (which includes ScotiaMcLeod and Scotia iTRADE), an investment dealer.

The Manager, on behalf of the Fund, may enter into transactions or arrangements with other members of Scotiabank or certain other companies that are related or connected to the Manager (each a "related party"). All transactions between the Fund and the related parties are in the normal course of business and are carried out at arm's length terms.

The purpose of this section is to provide a brief description of any transaction involving the Fund and a related party.

Fixed Administration Fees and Fund Costs

The Manager pays the operating expenses of the Fund, other than Fund Costs, in exchange for the payment by the Fund of a fixed rate administration fee (the “Fixed Administration Fee”) to the Manager with respect to each series of the Fund. The expenses charged to the Fund in respect of the Fixed Administration Fee are disclosed in the Fund’s financial statements. The Fixed Administration Fee is equal to a specified percentage of the net asset value of a series, calculated and paid in the same manner as the management fees for the Fund. Further details about the Fixed Administration Fee can be found in the Fund’s most recent simplified prospectus.

In addition, each series of the Fund is responsible for its proportionate share of certain operating expenses (“Fund Costs”). Further details about Fund Costs can be found in the Fund’s most recent simplified prospectus.

The Manager, at its sole discretion, may waive or absorb a portion of a series’ expenses. These waivers or absorptions may be terminated at any time without notice.

Other Fees

The Manager, or its affiliates, may earn fees and spreads in connection with various services provided to, or transactions with, the Fund, such as banking, custody, brokerage, foreign exchange or derivatives transactions. The Manager, or its affiliates, may earn a foreign exchange spread when unitholders switch between series of funds denominated in different currencies.

Independent Review Committee

The Manager has established an independent review committee (the “IRC”) in accordance with National Instrument 81-107 – Independent Review Committee for Investment Funds (“NI 81-107”) with a mandate to review and provide recommendations or approval, as required, on conflict of interest matters referred to it by the Manager on behalf of the Fund. The IRC is responsible for overseeing the Manager’s decisions in situations where the Manager is faced with any present or perceived conflicts of interest, all in accordance with NI 81-107.

The IRC may also approve certain mergers between the Fund and other funds, and any change of the auditor of the Fund. Subject to any corporate and securities law requirements, no securityholder approval will be obtained in such circumstances, but you will be sent a written notice at least 60 days before the effective date of any such transaction or change of auditor. In certain circumstances, securityholder approval may be required to approve certain mergers.

The IRC has five members, Stephen J. Griggs (Chair), Steven Donald, Simon Hitzig, Heather A. T. Hunter and Jennifer L. Witterick, each of whom is independent of the Manager.

The IRC prepares and files a report to the securityholders each fiscal year that describes the IRC and its activities for securityholders

as well as contains a complete list of the standing instructions. These standing instructions enable the Manager to act in a particular conflict of interest matter on a continuing basis provided the Manager complies with its policies and procedures established to address that conflict of interest matter and reports periodically to the IRC on the matter. This report to the securityholders is available on the Manager’s website or, at no cost, by contacting the Manager.

The compensation and other reasonable expenses of the IRC will be paid out of the assets of the Fund as well as out of the assets of the other investment funds for which the IRC may act as the independent review committee. Each member of the IRC receives an annual retainer of \$62,000 (\$77,000 for the Chair), plus expenses for each meeting. The fees and expenses, plus associated legal costs, are allocated among all of the funds managed by the Manager for which the IRC acts as the independent review committee in a manner that is considered by the Manager to be fair and reasonable. The main component of compensation is an annual retainer fee. Prior to November 1, 2021, each IRC member also received a fee for each committee meeting attended. Expenses of the IRC may include premiums for insurance coverage, travel expenses and reasonable out-of-pocket expenses.

The Manager, in respect of the Fund, received the following standing instructions from the IRC with respect to related party transactions:

- Paying brokerage commissions and spreads to a related party for effecting security transactions on an agency and principal basis on behalf of the Fund;
- Purchases or sales of securities of an issuer from or to another investment fund managed by the Manager;
- Investments in the securities of issuers for which a related underwriter acted as an underwriter during the distribution of such securities and the 60-day period following the completion of such distribution;
- Executing foreign exchange transactions with a related party on behalf of the Fund;
- Purchases of securities of a related party;
- Entering into over-the-counter derivatives on behalf of the Fund with a related party;
- Outsourcing products and services to related parties which can be charged to the Fund;
- Acquisition of prohibited securities as defined by securities regulations;
- Trading in mortgages with a related party;
- Entering into a designated broker agreement with a related party; and
- Entering into a prime broker agreement with a related party.

The Manager is required to advise the IRC of any breach of a condition of the standing instructions. The standing instructions require, among other things, that the investment decision in respect to a related party transaction: (a) is made by the Manager

free from any influence by an entity related to the Manager and without taking into account any consideration to any associate or affiliate of the Manager; (b) represents the business judgment of the Manager uninfluenced by considerations other than the best interests of the Fund; and (c) is made in compliance with the Manager's written policies and procedures. Transactions made by

the Manager under the standing instructions are subsequently reviewed by the IRC to monitor compliance.

The Manager, in respect of the Fund, did not rely on IRC standing instructions regarding related party transactions during the period.

The higher a fund's portfolio turnover rate in a period, the greater the trading costs payable by the fund in the period, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund.

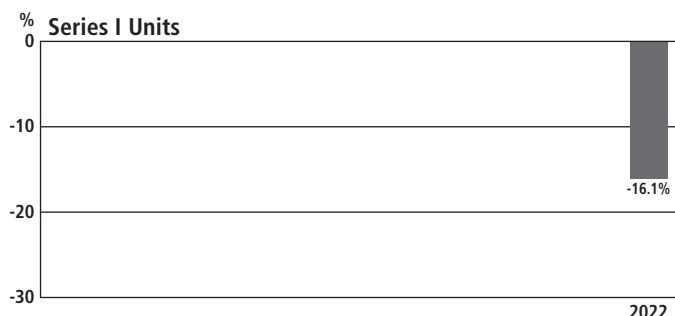
Past Performance
