1832 Asset Management L.P. is the manager (the "Manager") of the fund. In this document, "we", "us", "our" and the "Manager" refer to 1832 Asset Management L.P. and the "Fund" refers to Scotia Wealth Canadian Small Cap Pool.

The term "net asset value" or "net asset value per unit" in this document refers to the net asset value determined in accordance with Part 14 of National Instrument 81-106 — Investment Fund Continuous Disclosure ("National Instrument 81-106"); while the term "net assets" or "net assets per unit" refers to total equity or net assets attributable to unitholders of the Fund as determined in accordance with IFRS Accounting Standards.

Investment Objective and Strategies

The Fund's investment objective is to achieve superior long-term returns through capital growth by investing primarily in stocks of small and medium capitalization Canadian corporations.

The Fund uses a growth-oriented investment style that is moderated by price sensitivity (growth at a reasonable price) to achieve its investment objectives.

The Fund may invest up to 15% of its assets in cash and cash equivalents.

The Fund can invest up to 10% of its assets in foreign securities.

Risk

The risks associated with investing in the Fund are as described in the simplified prospectus. There were no material changes to the Fund over its last completed financial year that affected the overall level of risk of the Fund.

Results of Operations

For the year ended at December 31, 2024 (the "period"), the Pinnacle Series units of the Fund generated a total return of 21.4%. Fund returns are reported net of all management fees and expenses for all series, unlike the returns of the Fund's benchmark, which is based on the performance of an index that does not pay

fees or incur expenses. Returns for other series of the Fund will be similar to Pinnacle Series with any difference in performance being primarily due to different management fees, operating expenses and other expenses that are applicable to that particular series. Please see the "Past Performance" section for the performance of the Fund's other series.

The Fund's broad-based benchmark, the S&P/TSX Small Cap Total Return Index, returned 18.8% during the same period. In accordance with National Instrument 81-106, we have included a comparison to this broad-based index to help you understand the Fund's performance relative to the general performance of the market.

The Bank of Canada and the U.S. Federal Reserve Board ("Fed") signaled their intentions to bring their benchmark interest rates down gradually. Markets adjusted to this favourable change, immediately pushing up all risk assets, including Canadian equities. In December 2024, however, the Fed's positions shifted again, tempering investor expectations for 2025.

The Fed's change in positioning ended a strong rally in equities and other risk assets that had started in July. However, most of the strong gains achieved by Canadian and U.S. stocks in the first two months of the fourth quarter were erased by a broad pullback in December, as investors struggled to digest the Fed's more aggressive stance and the numerous uncertainties around the incoming Trump administration.

For Canadian and U.S. small-capitalization companies, declining interest rates and the outcome of the U.S. election appeared to set the stage for continued outperformance relative to large caps. While Canadian small caps outperformed large caps early in the fourth quarter, the pullback in November and December pushed small-cap stocks into negative territory for the rest of the year.

The Fund outperformed its benchmark as a result of solid stock selection. The Fund's strong absolute performance and significant value add versus the benchmark and other small-cap peers, was achieved despite market volatility. This backdrop was favourable to the Fund's investment style, which focuses on stock selection in companies with specific attributes and growth drivers.

The Fund's security selection contributed to performance, particularly in the Consumer Discretionary, Real Estate, Information Technology and Financials sectors. The Fund's underweight exposures to the Real Estate and Utilities sectors also contributed to performance. Individual contributors included MDA Space Ltd., a technology and service provider to the burgeoning global space industry. MDA Space reported solid results and strong business momentum throughout 2024 and its third-quarter results showed robust revenue growth in satellite systems, along with continued growth in space and robotics. Aritzia Inc. is a vertically integrated design house offering affordable everyday luxury. After a volatile 2023, the company was on track to achieve historical levels of revenue growth and margins and its stock price responded favourably to significant operational improvements. CWB Financial Group is a growthoriented full-service financial institution. CWB's share price rose after the June announcement that it would be acquired by

National Bank of Canada with each CWB share to be exchanged for 0.450 of a common share of National Bank, representing a 110% premium.

The Fund's stock selection in the Industrials, Materials and Energy sectors detracted from performance. The Fund's overweight exposures to the Information Technology, Industrials and Consumer Discretionary sectors detracted from performance, as did its underweight exposures to the Materials and Energy sectors. Individual detractors included Wajax Corp., one of Canada's leading diversified industrial products and services providers. Ultimately, 2024 was a soft year for equipment sales, which was partly due to the timing of large unit deliveries, a softening economic backdrop and spending-conscious customers. MATTR Corp. is a growth-oriented, global materials technology company broadly serving critical infrastructure markets. Share price weakness can be attributed to management's comments on softness for its Flexpipe products as well as weaker-than-expected automotive production. ATS Automation Tooling Systems Inc. is a custom engineer and producer of industrial automated manufacturing systems for industrial end markets including electric vehicles ("EV"). ATS saw its overall organic growth slow considerably owing to a lull in EV-related bookings and revenues and its largest EV customer announced it was suspending its EV battery assembly contract with ATS.

New positions included Boyd Group Services Inc., Richard Packaging Inc., Cineplex Inc., Hamilton Thorne Ltd., Wajax, Biosyent Inc. and 5N Plus Inc.

Increased positions included MATTR and Computer Modelling Group Ltd., which were purchased at attractive prices, given their organic and acquisition growth potential.

Decreased positions included Aritzia and Adentra Inc. on valuation and position weight considerations.

Eliminated positions included Logistec Corporation, CWB Financial Group, Sleep Country Canada Holdings Inc. and Hamilton Thorne Ltd., which were sold following takeovers. Spin Master Corp., Leon's Furniture Ltd., Linamar Corp., Canada Goose Holdings Inc. and several other positions were also sold. These sales funded new and increased positions that had both better organic growth and prospects for growth by acquisition.

The Fund's net asset value increased to \$92.0 million at December 31, 2024, from \$75.5 million at December 31, 2023. This change was composed of net sales of \$1.1 million, and investment performance of \$15.5 million and cash distributions of \$0.1 million. The investment performance of the Fund includes income and expenses which vary year over year. The Fund's income and expenses changed compared to the previous year mainly as a result of fluctuations in average net assets, portfolio activity and changes in the Fund's income earning investments.

Certain series of the Fund, as applicable, may make distributions at a rate determined by the Manager from time to time. If the aggregate amount of distributions in such series exceeds the portion of net income and net realized capital gains allocated to such series, the excess will constitute a return of capital. The Manager does not believe that the return of capital distributions

made by such series of the Fund have a meaningful impact on the Fund's ability to implement its investment strategy or to fulfill its investment objective.

Recent Developments

There have been no recent developments that have affected, or are likely to materially affect the Fund.

Related Party Transactions

The Manager is a wholly-owned subsidiary of The Bank of Nova Scotia ("Scotiabank"). Scotiabank also owns, directly or indirectly, 100% of Scotia Securities Inc., a mutual fund dealer, and Scotia Capital Inc. (which includes ScotiaMcLeod and Scotia iTRADE), an investment dealer.

The Manager, on behalf of the Fund, may enter into transactions or arrangements with other members of Scotiabank or certain other companies that are related or connected to the Manager (each a "related party"). All transactions between the Fund and the related parties are in the normal course of business and are carried out at arm's length terms.

The purpose of this section is to provide a brief description of any transaction involving the Fund and a related party.

Management Fees

The Manager is responsible for the day-to-day management and operations of the Fund. Certain series of the Fund pay the Manager a management fee for its services as described in the "Management Fee" section later in this document. The management fee is an annualized rate based on the net asset value of each series of the Fund, accrued daily and paid monthly.

Fixed Administration Fees and Fund Costs

The Manager pays the operating expenses of the Fund, other than Fund Costs, in exchange for the payment by the Fund of a fixed rate administration fee (the "Fixed Administration Fee") to the Manager with respect to each series of the Fund. The expenses charged to the Fund in respect of the Fixed Administration Fee are disclosed in the Fund's financial statements. The Fixed Administration Fee is equal to a specified percentage of the net asset value of a series, calculated and paid in the same manner as the management fees for the Fund. Further details about the Fixed Administration Fee can be found in the Fund's most recent simplified prospectus.

In addition, each series of the Fund is responsible for its proportionate share of certain operating expenses ("Fund Costs"). Further details about Fund Costs can be found in the Fund's most recent simplified prospectus.

The Manager, at its sole discretion, may waive or absorb a portion of a series' expenses. These waivers or absorptions may be terminated at any time without notice.

Related Brokerage Commissions

From time to time, the Fund may enter into portfolio securities transactions with Scotia Capital Inc. or other related dealers in

whom Scotiabank has a significant interest (a "Related Broker"). These Related Brokers may earn commission or spreads on such transactions, which are made on terms and conditions that are comparable to transactions made with non-related brokers.

During the period, the Fund paid \$3,000 in commissions to Related Brokers.

Other Fees

The Manager, or its affiliates, may earn fees and spreads in connection with various services provided to, or transactions with, the Fund, such as banking, custody, brokerage, foreign exchange or derivatives transactions. The Manager, or its affiliates, may earn a foreign exchange spread when unitholders switch between series of funds denominated in different currencies.

Independent Review Committee

The Manager has established an independent review committee (the "IRC") in accordance with National Instrument 81-107 — Independent Review Committee for Investment Funds ("NI 81-107") with a mandate to review and provide recommendations or approval, as required, on conflict of interest matters referred to it by the Manager on behalf of the Fund. The IRC is responsible for overseeing the Manager's decisions in situations where the Manager is faced with any present or perceived conflicts of interest, all in accordance with NI 81-107.

The IRC may also approve certain mergers between the Fund and other funds, and any change of the auditor of the Fund. Subject to any corporate and securities law requirements, no securityholder approval will be obtained in such circumstances, but you will be sent a written notice at least 60 days before the effective date of any such transaction or change of auditor. In certain circumstances, securityholder approval may be required to approve certain mergers.

The IRC has five members, Stephen J. Griggs (Chair), Steven Donald, Heather A. T. Hunter, Cecilia Mo and Jennifer L. Witterick, each of whom is independent of the Manager.

The IRC prepares and files a report to the securityholders each fiscal year that describes the IRC and its activities for securityholders as well as contains a complete list of the standing instructions. These standing instructions enable the Manager to act in a particular conflict of interest matter on a continuing basis provided the Manager complies with its policies and procedures established to address that conflict of interest matter and reports periodically to the IRC on the matter. This report to the securityholders is available on the Manager's website or, at no cost, by contacting the Manager.

The compensation and other reasonable expenses of the IRC will be paid out of the assets of the Fund as well as out of the assets of the other investment funds for which the IRC may act as the independent review committee. Each member of the IRC receives an annual retainer of \$62,000 (\$77,000 for the Chair), plus expenses for each meeting. The fees and expenses, plus associated legal costs, are split equally among all of the funds managed by the Manager for which the IRC acts as the independent review

committee. The main component of compensation is an annual retainer fee. Expenses of the IRC may include premiums for insurance coverage, travel expenses and reasonable out-of-pocket expenses.

The Manager, in respect of the Fund, received the following standing instructions from the IRC with respect to related party transactions:

- Paying brokerage commissions and spreads to a related party for effecting security transactions on an agency and principal basis on behalf of the Fund:
- Purchases or sales of securities of an issuer from or to another investment fund managed by the Manager;
- Investments in the securities of issuers for which a related underwriter acted as an underwriter during the distribution of such securities and the 60-day period following the completion of such distribution;
- Executing foreign exchange transactions with a related party on behalf of the Fund:
- Purchases of securities of a related party;
- Entering into over-the-counter derivatives on behalf of the Fund with a related party;

- Outsourcing products and services to related parties which can be charged to the Fund;
- Acquisition of prohibited securities as defined by securities regulations;
- Trading in mortgages with a related party;
- Entering into a designated broker agreement with a related party; and
- Entering into a prime broker agreement with a related party.

The Manager is required to advise the IRC of any breach of a condition of the standing instructions. The standing instructions require, among other things, that the investment decision in respect to a related party transaction: (a) is made by the Manager free from any influence by an entity related to the Manager and without taking into account any consideration to any associate or affiliate of the Manager; (b) represents the business judgment of the Manager uninfluenced by considerations other than the best interests of the Fund; and (c) is made in compliance with the Manager's written policies and procedures. Transactions made by the Manager under the standing instructions are subsequently reviewed by the IRC to monitor compliance.

The Manager, in respect of the Fund, relied on IRC standing instructions regarding related party transactions during the period.

- (3) The trading expense ratio represents total commissions and other portfolio transaction costs, short borrowing costs and interest on leverage of the Fund and the underlying funds, where applicable, expressed as an annualized percentage of daily average net asset value of the Fund during the period.
- (4) The Fund's portfolio turnover rate indicates how actively the Fund's portfolio advisor manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the period. The higher a fund's portfolio turnover rate in a period, the greater the trading costs payable by the fund in the period, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund.

Management Fees

The management fee is an annualized rate based on the net asset value of each series of the Fund, accrued daily and paid monthly. The management fees cover the costs of managing the Fund, arranging for investment analysis, recommendations and investment decision making for the Fund, arranging for distribution of the Fund, marketing and promotion of the Fund and providing or arranging for other services.

The breakdown of services received in consideration of management fees for each series, as a percentage of the management fees, are as follows:






Year-by-Year Returns
