1832 Asset Management L.P. is the manager (the "Manager") of the fund. In this document, "we", "us", "our" and the "Manager" refer to 1832 Asset Management L.P. and the "Fund" refers to Scotia Wealth Emerging Markets Pool.

The term "net asset value" or "net asset value per unit" in this document refers to the net asset value determined in accordance with Part 14 of National Instrument 81-106 – Investment Fund Continuous Disclosure ("National Instrument 81-106"); while the term "net assets" or "net assets per unit" refers to total equity or net assets attributable to unitholders of the Fund as determined in accordance with International Financial Reporting Standards ("IFRS").

Investment Objective and Strategies

The Fund's investment objective is to achieve long term returns through capital growth by investing primarily in equity and equity-related securities of companies located in emerging markets and emerging industries of any market.

The Fund uses a growth oriented investment style to achieve its investment objectives.

The portfolio advisor analyzes the global economy and the economies and industries of various emerging markets. Based on this analysis, it identifies the countries and then the companies that it believes offer the potential for growth. The portfolio advisor uses techniques such as fundamental analysis to assess growth potential. This means evaluating the financial condition and management of a company, its industry and the overall economy through due diligence, including meetings with companies' management, financial statement analysis and modeling. The portfolio advisor also focuses on the upside potential versus the downside risk of each security.

The Fund can invest up to 100% of its assets in foreign securities.

Risk

The risks associated with investing in the Fund are as described in the simplified prospectus. There were no material changes to the Fund over its last completed financial year that affected the overall level of risk of the Fund.

Results of Operations

For the year ended December 31, 2022 (the “period”), the Pinnacle Series units of the Fund generated a total return of – 18.4%. Fund returns are reported net of all management fees and expenses for all series, unlike the returns of the Fund’s benchmark, which is based on the performance of an index that does not pay fees or incur expenses. Returns for other series of the Fund will be similar to Pinnacle Series with any difference in performance being primarily due to different management fees, operating expenses and other expenses that are applicable to that particular series. Please see the “Past Performance” section for the performance of the Fund’s other series.

The Fund’s broad-based benchmark, the MSCI Emerging Markets Index (C\$), returned – 14.5% during the same period. In accordance with National Instrument 81-106, we have included a comparison to this broad-based index to help you understand the Fund’s performance relative to the general performance of the market.

Emerging markets equities declined over the first the three quarters of 2022. In the first quarter, the Russia – Ukraine conflict created volatility, and a large COVID-19 outbreak in China prompted lockdowns that threatened to disrupt supply chains. As a result, Asian equities underperformed. Conversely, the conflict in Ukraine drove energy, grains and metals prices sharply higher, which benefited Latin American economies that rely heavily on commodity exports, such as Peru, Chile, Colombia, Brazil and Mexico.

In the second quarter, global economic conditions decelerated amid elevated geopolitical tensions, ongoing supply chain disruptions and surging food and energy prices. Central banks’ interest rate increases also weighed on investor sentiment. Asian equities fell, with broad risk-averse sentiment and expectations for higher inflation putting pressure on most countries.

Latin American equities were bolstered by Brazil in the third quarter, as its central bank raised interest rates by 50 basis points (“bps”). In Mexico, consumer prices rose at a faster-than-expected pace, prompting its central bank to implement two interest rate increases of 75 bps each to curb inflation and support the peso. Eastern European emerging equity markets declined as the Russia – Ukraine conflict cut off many traditional supply routes for food and energy. Asian equities continued to struggle with China’s “zero COVID-19” policy, weakening global demand and a worsening property market crisis.

In the fourth quarter, emerging markets equities rebounded, with Asia outperforming Europe, the Middle East and Africa (“EMEA”) and Latin America. Asia was led higher by strong returns in China as stringent pandemic policies were unwound. Eastern European nations continued to struggle with elevated inflation and the impact of the conflict in Ukraine. In Brazil, economic growth forecasts for 2023 were cut in response to higher interest rates, fiscal uncertainty and a weaker global economy.

The Fund underperformed the broad-based benchmark as a result of stock selection in the Information Technology, Energy and Utilities sectors, and underweight exposure to the Consumer Staples and Consumer Discretionary sectors.

Top individual detractors included XPeng Inc., Gazprom PJSC and Lukoil PJSC. Shares of XPeng declined after management lowered guidance for third-quarter vehicle deliveries. Rising raw material costs and lockdowns in China have affected electric vehicle (“EV”) sales and product utilization. Shares of Gazprom and Lukoil fell as economic sanctions against Russia eliminated almost US\$200 billion in stock market value.

Stock selection in the Financials, Consumer Discretionary and Consumer Staples sectors contributed to performance, as did an overweight position in the Utilities sector. Top individual contributors included Sands China Ltd., AIA Group Ltd. and Axis Bank Ltd.

Shares of Sands China rebounded after the company was announced as one of six casino operators to be granted provisional licenses to continue operating in Macau for the next 10 years, removing a key regulatory challenge. Pandemic-related travel restrictions have impacted AIA Group’s mainland Chinese business, but this should improve as the country reopens. In addition, the company is taking steps to improve the business over the long term with its technology, digital and analytics program, and the expansion of its health business. Shares of Axis Bank rose as earnings results exceeded consensus estimates. India’s banking system is benefiting from robust credit growth as the economy reopens, the real estate market recovers and pandemic restrictions are lifted.

During the period, electronic device manufacturer Hon Hai Precision Industry Co. Ltd. was added to the Fund. The company has upside margin potential, a relatively defensive position amid a rising-cost environment and optionality from the EV business. The Fund’s position in Banco Bradesco SA, the second-largest private bank in Brazil, was increased. The bank should benefit from rebounding commodity prices and a higher interest rate environment.

The Fund’s holding in ICICI Bank Ltd. was exited in favour of other Indian banks whose valuations and growth prospects are viewed as slightly more compelling. In addition, Tencent Holdings Ltd. was trimmed as part of the Fund’s risk rebalancing process.

The Fund’s net asset value decreased to \$54.2 million at December 31, 2022, from \$69.9 million at December 31, 2021. This change was composed of investment performance of negative \$13.1 million, net redemptions of \$2.6 million and cash distributions of \$11,707. The investment performance of the Fund includes income and expenses which vary year over year. The Fund’s income and expenses changed compared to the previous year mainly as a result of fluctuations in average net assets, portfolio activity and changes in the Fund’s income earning investments.

Certain series of the Fund, as applicable, may make distributions at a rate determined by the Manager from time to time. If the aggregate amount of distributions in such series exceeds the portion of net income and net realized capital gains allocated to such series, the excess will constitute a return of capital. The Manager does not believe that the return of capital distributions made by

such series of the Fund have a meaningful impact on the Fund's ability to implement its investment strategy or to fulfill its investment objective.

Recent Developments

Russia and Ukraine Conflict

Since the start of the conflict in late February 2022, Russian securities have declined in value due to economic sanctions placed on Russia and certain of its citizens. Price volatility, trading restrictions, including the potential for extended halting of Russian market trading, and general default risk related to Russian securities held by the Fund have increased substantially since December 31, 2021. The Manager will continue to monitor the situation and the effects on the Fund.

Related Party Transactions

The Manager is a wholly-owned subsidiary of The Bank of Nova Scotia ("Scotiabank"). Scotiabank also owns, directly or indirectly, 100% of Scotia Securities Inc., a mutual fund dealer, and Scotia Capital Inc. (which includes ScotiaMcLeod and Scotia iTRADE), an investment dealer.

The Manager, on behalf of the Fund, may enter into transactions or arrangements with other members of Scotiabank or certain other companies that are related or connected to the Manager (each a "related party"). All transactions between the Fund and the related parties are in the normal course of business and are carried out at arm's length terms.

The purpose of this section is to provide a brief description of any transaction involving the Fund and a related party.

Management Fees

The Manager is responsible for the day-to-day management and operations of the Fund. Certain series of the Fund pay the Manager a management fee for its services as described in the "Management Fee" section later in this document. The management fee is an annualized rate based on the net asset value of each series of the Fund, accrued daily and paid monthly.

Fixed Administration Fees and Fund Costs

The Manager pays the operating expenses of the Fund, other than Fund Costs, in exchange for the payment by the Fund of a fixed rate administration fee (the "Fixed Administration Fee") to the Manager with respect to each series of the Fund. The expenses charged to the Fund in respect of the Fixed Administration Fee are disclosed in the Fund's financial statements. The Fixed Administration Fee is equal to a specified percentage of the net asset value of a series, calculated and paid in the same manner as the management fees for the Fund. Further details about the Fixed Administration Fee can be found in the Fund's most recent simplified prospectus.

In addition, each series of the Fund is responsible for its proportionate share of certain operating expenses ("Fund Costs"). Further details about Fund Costs can be found in the Fund's most recent simplified prospectus.

The Manager, at its sole discretion, may waive or absorb a portion of a series' expenses. These waivers or absorptions may be terminated at any time without notice.

Other Fees

The Manager, or its affiliates, may earn fees and spreads in connection with various services provided to, or transactions with, the Fund, such as banking, custody, brokerage, foreign exchange or derivatives transactions. The Manager, or its affiliates, may earn a foreign exchange spread when unitholders switch between series of funds denominated in different currencies.

Independent Review Committee

The Manager has established an independent review committee (the "IRC") in accordance with National Instrument 81-107 – Independent Review Committee for Investment Funds ("NI 81-107") with a mandate to review and provide recommendations or approval, as required, on conflict of interest matters referred to it by the Manager on behalf of the Fund. The IRC is responsible for overseeing the Manager's decisions in situations where the Manager is faced with any present or perceived conflicts of interest, all in accordance with NI 81-107.

The IRC may also approve certain mergers between the Fund and other funds, and any change of the auditor of the Fund. Subject to any corporate and securities law requirements, no securityholder approval will be obtained in such circumstances, but you will be sent a written notice at least 60 days before the effective date of any such transaction or change of auditor. In certain circumstances, securityholder approval may be required to approve certain mergers.

The IRC has five members, Stephen J. Griggs (Chair), Steven Donald, Simon Hitzig, Heather A. T. Hunter and Jennifer L. Witterick, each of whom is independent of the Manager.

The IRC prepares and files a report to the securityholders each fiscal year that describes the IRC and its activities for securityholders as well as contains a complete list of the standing instructions. These standing instructions enable the Manager to act in a particular conflict of interest matter on a continuing basis provided the Manager complies with its policies and procedures established to address that conflict of interest matter and reports periodically to the IRC on the matter. This report to the securityholders is available on the Manager's website or, at no cost, by contacting the Manager.

The compensation and other reasonable expenses of the IRC will be paid out of the assets of the Fund as well as out of the assets of the other investment funds for which the IRC may act as the independent review committee. Each member of the IRC receives an annual retainer of \$62,000 (\$77,000 for the Chair), plus expenses for each meeting. The fees and expenses, plus associated legal costs, are allocated among all of the funds managed by the Manager for which the IRC acts as the independent review committee in a manner that is considered by the Manager to be fair and reasonable. The main component of compensation is an annual retainer fee. Prior to November 1, 2021, each IRC member

also received a fee for each committee meeting attended. Expenses of the IRC may include premiums for insurance coverage, travel expenses and reasonable out-of-pocket expenses.

The Manager, in respect of the Fund, received the following standing instructions from the IRC with respect to related party transactions:

- Paying brokerage commissions and spreads to a related party for effecting security transactions on an agency and principal basis on behalf of the Fund;
- Purchases or sales of securities of an issuer from or to another investment fund managed by the Manager;
- Investments in the securities of issuers for which a related underwriter acted as an underwriter during the distribution of such securities and the 60-day period following the completion of such distribution;
- Executing foreign exchange transactions with a related party on behalf of the Fund;
- Purchases of securities of a related party;
- Entering into over-the-counter derivatives on behalf of the Fund with a related party;
- Outsourcing products and services to related parties which can be charged to the Fund;

- Acquisition of prohibited securities as defined by securities regulations;
- Trading in mortgages with a related party;
- Entering into a designated broker agreement with a related party; and
- Entering into a prime broker agreement with a related party.

The Manager is required to advise the IRC of any breach of a condition of the standing instructions. The standing instructions require, among other things, that the investment decision in respect to a related party transaction: (a) is made by the Manager free from any influence by an entity related to the Manager and without taking into account any consideration to any associate or affiliate of the Manager; (b) represents the business judgment of the Manager uninfluenced by considerations other than the best interests of the Fund; and (c) is made in compliance with the Manager's written policies and procedures. Transactions made by the Manager under the standing instructions are subsequently reviewed by the IRC to monitor compliance.

The Manager, in respect of the Fund, did not rely on IRC standing instructions regarding related party transactions during the period.

⁽³⁾ The trading expense ratio represents total commissions and other portfolio transaction costs, short borrowing costs and interest on leverage of the Fund and the underlying funds, where applicable, expressed as an annualized percentage of daily average net asset value of the Fund during the period.

⁽⁴⁾ The Fund's portfolio turnover rate indicates how actively the Fund's portfolio advisor manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the period. The higher a fund's portfolio turnover rate in a period, the greater the trading costs payable by the fund in the period, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund.

Management Fees

The management fee is an annualized rate based on the net asset value of each series of the Fund, accrued daily and paid monthly. The management fees cover the costs of managing the Fund, arranging for investment analysis, recommendations and investment decision making for the Fund, arranging for distribution of the Fund, marketing and promotion of the Fund and providing or arranging for other services.

The breakdown of services received in consideration of management fees for each series, as a percentage of the management fees, are as follows:

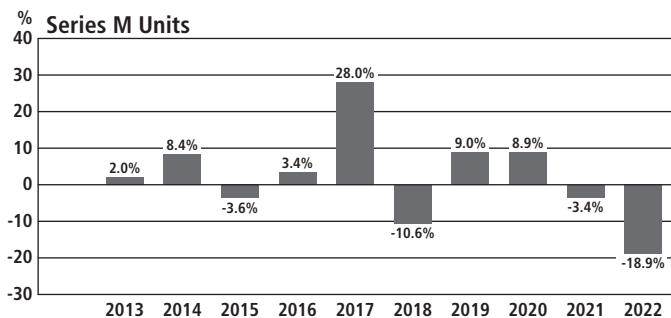
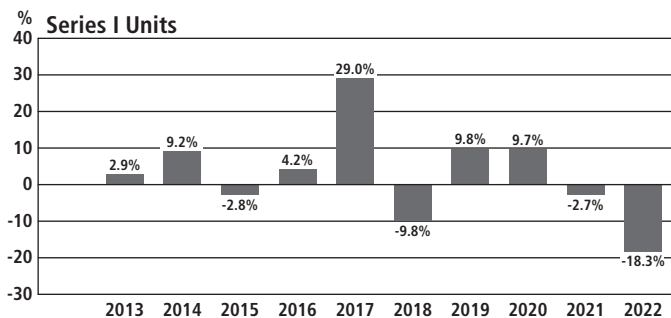
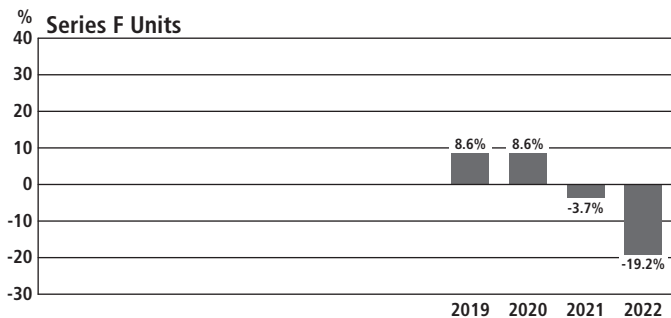
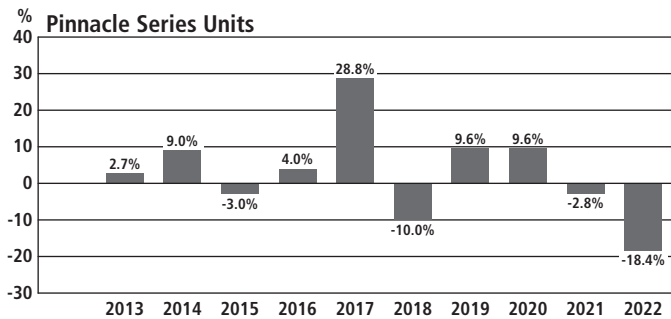

Past Performance

The following shows the past performance for each series and will not necessarily indicate how the Fund will perform in the future. The information shown assumes that all distributions made by each series of the Fund in the periods shown were reinvested in additional units of the relevant series. In addition, the information does not take into account sales, redemption, distribution or other optional charges that would have reduced returns or performance.

Year-By-Year Returns

The following charts show the performance for each series of the Fund and illustrate how performance has varied from year to year. The charts show, in percentage terms, how much an investment held on the first day of each calendar year would have increased or decreased by the last day of each calendar year for that series.



Annual Compound Returns
