1832 Asset Management L.P. is the manager (the "Manager") of the fund. In this document, "we", "us", "our" and the "Manager" refer to 1832 Asset Management L.P. and the "Fund" refers to Scotia U.S. Opportunities Fund.

The term "net asset value" or "net asset value per unit" in this document refers to the net asset value determined in accordance with Part 14 of National Instrument 81-106 — Investment Fund Continuous Disclosure ("National Instrument 81-106"); while the term "net assets" or "net assets per unit" refers to total equity or net assets attributable to unitholders of the Fund as determined in accordance with IFRS Accounting Standards.

Investment Objective and Strategies

The Fund's investment objective is to achieve long-term capital growth. It invests primarily in equity securities of U.S. companies.

The portfolio adviser uses fundamental analysis to identify companies that are priced below their estimated intrinsic value. This involves evaluating the financial condition and management of each company relative to its industry and sector peers. The Fund's assets are diversified by industry and company to help reduce risk.

The Fund can invest up to 100% of its assets in foreign securities.

Risk

The risks associated with investing in the Fund are as described in the simplified prospectus. There were no material changes to the Fund over its last completed financial year that affected the overall level of risk of the Fund.

Results of Operations

For the year ended at December 31, 2024 (the "period"), the Series A units of the Fund generated a total return of 16.9%. Fund returns are reported net of all management fees and expenses for all series, unlike the returns of the Fund's benchmark, which is based on the performance of an index that does not pay fees or

incur expenses. Returns for other series of the Fund will be similar to Series A with any difference in performance being primarily due to different management fees, operating expenses and other expenses that are applicable to that particular series. Please see the "Past Performance" section for the performance of the Fund's other series.

The Fund's broad-based benchmark, the S&P 500 Index (C\$), returned 36.1% during the same period. In accordance with National Instrument 81-106, we have included a comparison to this broad-based index to help you understand the Fund's performance relative to the general performance of the market.

Over the period, investors seemingly favoured momentum and growth expectations over cash flow generation and earnings stability, as evidenced by the low-quality nature of the ongoing rally. Three federal funds rate cuts in 2024, coupled with stable economic growth, raised hopes that the U.S. economy could achieve a "soft landing."

The Fund significantly underperformed the broad-based benchmark primarily owing to the outperformance of lowerquality stocks and lack of exposure to benchmark companies that produced significant gains.

The Fund's security selection in the Information Technology, Consumer Discretionary and Consumer Staples sectors were the primary detractors from performance. The Fund's significantly overweight exposure to high-quality stocks detracted from performance as lower-quality stocks continued their rally. Individual detractors included Nike Inc., which reported mixed financial results. The company initially forecast a revenue and earnings decline for fiscal year 2025 before withdrawing financial guidance in connection with an executive leadership change. Zoetis Inc. underperformed owing to concerns over future growth in its monoclonal antibody pain relief treatments for pets, one of which resulted in a warning letter from the U.S. Food and Drug Administration regarding consumer complaints about side effects, particularly in geriatric pets. PepsiCo Inc. lowered its fiscal year 2024 organic sales estimates during the third quarter amid concerns about the potential effects of GLP-1 weight loss drugs on snack and beverage sales over time, as well as slowing organic sales growth. Additionally, Pepsi is a defensive stock that typically underperforms during strong market rallies.

The Fund's lack of exposure to the Energy, Utilities and Real Estate sectors contributed to performance. The Fund's stock selection in the Materials sector also contributed, largely owing to The Sherwin-Williams Company, which has grown despite lower housing activity. Individual contributors included Apple Inc. as its share price rose amid investor excitement over the initial integration of artificial intelligence ("AI") capabilities in the newly launched iPhone 16. Alphabet Inc.'s shares rose owing to its progress in integrating AI features into its products and services and the company achieved a key milestone in quantum computing research. Stryker Corp.'s shares rose owing to better-than-expected financial results that were driven by share gains in the company's orthopedic and hospital equipment businesses.

New positions included Sherwin-Williams, Zoetis, McDonald's Corp., Copart, Inc. and Cadence Design Systems, Inc. Sherwin-Williams is a leading manufacturer and retailer of paint, coatings and related products to professional, industrial, commercial and retail customers. The company demonstrates sustainable competitive advantages, consistently high returns on equity, an excellent management team and corporate culture and ample generation of free cash flow. Zoetis develops, manufactures and markets animal health medicines, vaccines, diagnostic products, genetic tests and biodevices. The animal health industry has high barriers to entry and solid long-term growth drivers, such as an increasing focus on treating pet diseases, a growing pet population and significant unmet needs in both pet and livestock care. McDonald's franchises fast-food restaurants in over 100 countries. The company generates revenues primarily from royalty payments, which are calculated as a percentage of franchisee sales. Copart operates auctions and wrecking yards for salvagetitle vehicles supplied mostly by insurance companies. Copart enjoys several competitive advantages, leading to higher auction prices and better returns for insurance companies. Cadence provides software, hardware, services and licenses for intellectual property to companies that design semiconductors, circuit boards and computer systems. Cadence holds a strong market position in a duopolistic market, particularly in analog semiconductor design tools and has strong competitive advantages. including high customer switching costs, high barriers to entry and a large intellectual property portfolio. Additionally, the company benefits from a high proportion of recurring revenue, solid long-term growth drivers, a strong balance sheet and high profitability.

Eliminated positions from the Fund included Moody's Corp., Pfizer Inc., Starbucks Corp. and Ball Corp. Moody's is a global risk assessment firm that is best known for its investor services and credit ratings. The position was sold as the stock price exceeded our estimate of full value. Pfizer is a global biopharmaceuticals company. The position was sold owing to the company's "stretched" balance sheet and constrained free-cash-flow generation. Starbucks is a global restaurant company that roasts, markets and retails specialty coffee. The company's financial performance has been negatively impacted by increased competition in its China operations and waning consumer sentiment. Ball Corp. is the world's largest aluminum beverage can manufacturer. Its volatile sales volumes reduced our confidence in the business' long-term stability.

The Fund's net asset value decreased to \$353.5 million at December 31, 2024, from \$436.6 million at December 31, 2023. This change was composed of net redemptions of \$151.9 million, and investment performance of \$68.8 million. The investment performance of the Fund includes income and expenses which vary year over year. The Fund's income and expenses changed compared to the previous year mainly as a result of fluctuations in average net assets, portfolio activity and changes in the Fund's income earning investments and changes in fixed administration fees.

Certain series of the Fund, as applicable, may make distributions at a rate determined by the Manager from time to time. If the aggregate amount of distributions in such series exceeds the portion of net income and net realized capital gains allocated to such series, the excess will constitute a return of capital. The

Manager does not believe that the return of capital distributions made by such series of the Fund have a meaningful impact on the Fund's ability to implement its investment strategy or to fulfill its investment objective.

Recent Developments

Fixed Administration Fee Change

Effective December 6, 2024, the fixed administration fee charged to the Series A and F units of the Fund was reduced from 0.35% to 0.25%.

Related Party Transactions

The Manager is a wholly-owned subsidiary of The Bank of Nova Scotia ("Scotiabank"). Scotiabank also owns, directly or indirectly, 100% of Scotia Securities Inc., a mutual fund dealer, and Scotia Capital Inc. (which includes ScotiaMcLeod and Scotia iTRADE), an investment dealer.

The Manager, on behalf of the Fund, may enter into transactions or arrangements with other members of Scotiabank or certain other companies that are related or connected to the Manager (each a "related party"). All transactions between the Fund and the related parties are in the normal course of business and are carried out at arm's length terms.

The purpose of this section is to provide a brief description of any transaction involving the Fund and a related party.

Management Fees

The Manager is responsible for the day-to-day management and operations of the Fund. Certain series of the Fund pay the Manager a management fee for its services as described in the "Management Fee" section later in this document. The management fee is an annualized rate based on the net asset value of each series of the Fund, accrued daily and paid monthly.

Fixed Administration Fees and Fund Costs

The Manager pays the operating expenses of the Fund, other than Fund Costs, in exchange for the payment by the Fund of a fixed rate administration fee (the "Fixed Administration Fee") to the Manager with respect to each series of the Fund. The expenses charged to the Fund in respect of the Fixed Administration Fee are disclosed in the Fund's financial statements. The Fixed Administration Fee is equal to a specified percentage of the net asset value of a series, calculated and paid in the same manner as the management fees for the Fund. Further details about the Fixed Administration Fee can be found in the Fund's most recent simplified prospectus.

In addition, each series of the Fund is responsible for its proportionate share of certain operating expenses ("Fund Costs"). Further details about Fund Costs can be found in the Fund's most recent simplified prospectus.

The Manager, at its sole discretion, may waive or absorb a portion of a series' expenses. These waivers or absorptions may be terminated at any time without notice.

Distribution Services

Certain registered dealers through which units of the Fund are distributed are related parties to the Fund and the Manager. The Manager may pay a trailing commission, which is negotiated with dealers, to dealers for their financial advisors in respect of the assets of their clients invested in securities of the Fund. The Manager, during the period, could also pay trailing commissions to dealers for securities purchased or held through discount brokerage accounts.

Other Fees

The Manager, or its affiliates, may earn fees and spreads in connection with various services provided to, or transactions with, the Fund, such as banking, custody, brokerage, foreign exchange or derivatives transactions. The Manager, or its affiliates, may earn a foreign exchange spread when unitholders switch between series of funds denominated in different currencies.

Independent Review Committee

The Manager has established an independent review committee (the "IRC") in accordance with National Instrument 81-107 — Independent Review Committee for Investment Funds ("NI 81-107") with a mandate to review and provide recommendations or approval, as required, on conflict of interest matters referred to it by the Manager on behalf of the Fund. The IRC is responsible for overseeing the Manager's decisions in situations where the Manager is faced with any present or perceived conflicts of interest, all in accordance with NI 81-107.

The IRC may also approve certain mergers between the Fund and other funds, and any change of the auditor of the Fund. Subject to any corporate and securities law requirements, no securityholder approval will be obtained in such circumstances, but you will be sent a written notice at least 60 days before the effective date of any such transaction or change of auditor. In certain circumstances, securityholder approval may be required to approve certain mergers.

The IRC has five members, Stephen J. Griggs (Chair), Steven Donald, Heather A. T. Hunter, Cecilia Mo and Jennifer L. Witterick, each of whom is independent of the Manager.

The IRC prepares and files a report to the securityholders each fiscal year that describes the IRC and its activities for securityholders as well as contains a complete list of the standing instructions. These standing instructions enable the Manager to act in a particular conflict of interest matter on a continuing basis provided the Manager complies with its policies and procedures established to address that conflict of interest matter and reports periodically to the IRC on the matter. This report to the securityholders is available on the Manager's website or, at no cost, by contacting the Manager.

The compensation and other reasonable expenses of the IRC will be paid out of the assets of the Fund as well as out of the assets of the other investment funds for which the IRC may act as the independent review committee. Each member of the IRC receives an annual retainer of \$62,000 (\$77,000 for the Chair), plus

expenses for each meeting. The fees and expenses, plus associated legal costs, are split equally among all of the funds managed by the Manager for which the IRC acts as the independent review committee. The main component of compensation is an annual retainer fee. Expenses of the IRC may include premiums for insurance coverage, travel expenses and reasonable out-of-pocket expenses.

The Manager, in respect of the Fund, received the following standing instructions from the IRC with respect to related party transactions:

- Paying brokerage commissions and spreads to a related party for effecting security transactions on an agency and principal basis on behalf of the Fund:
- Purchases or sales of securities of an issuer from or to another investment fund managed by the Manager;
- Investments in the securities of issuers for which a related underwriter acted as an underwriter during the distribution of such securities and the 60-day period following the completion of such distribution;
- Executing foreign exchange transactions with a related party on behalf of the Fund;
- Purchases of securities of a related party;
- Entering into over-the-counter derivatives on behalf of the Fund with a related party;

- Outsourcing products and services to related parties which can be charged to the Fund;
- Acquisition of prohibited securities as defined by securities regulations;
- Trading in mortgages with a related party;
- Entering into a designated broker agreement with a related party; and
- Entering into a prime broker agreement with a related party.

The Manager is required to advise the IRC of any breach of a condition of the standing instructions. The standing instructions require, among other things, that the investment decision in respect to a related party transaction: (a) is made by the Manager free from any influence by an entity related to the Manager and without taking into account any consideration to any associate or affiliate of the Manager; (b) represents the business judgment of the Manager uninfluenced by considerations other than the best interests of the Fund; and (c) is made in compliance with the Manager's written policies and procedures. Transactions made by the Manager under the standing instructions are subsequently reviewed by the IRC to monitor compliance.

The Manager, in respect of the Fund, did not rely on IRC standing instructions regarding related party transactions during the period.

The higher a fund's portfolio turnover rate in a period, the greater the trading costs payable by the fund in the period, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund.

Management Fees

The management fee is an annualized rate based on the net asset value of each series of the Fund, accrued daily and paid monthly. The management fees cover the costs of managing the Fund, arranging for investment analysis, recommendations and investment decision making for the Fund, arranging for distribution of the Fund, marketing and promotion of the Fund and providing or arranging for other services.






reinvested in additional units of the relevant series. In addition, the information does not take into account sales, redemption, distribution or other optional charges that would have reduced returns or performance.
