1832 Asset Management L.P. is the manager (the "Manager") of the fund. In this document, "we", "us", "our" and the "Manager" refer to 1832 Asset Management L.P. and the "Fund" refers to Scotia Income Advantage Fund.

The term "net asset value" or "net asset value per unit" in this document refers to the net asset value determined in accordance with Part 14 of National Instrument 81-106 – Investment Fund Continuous Disclosure ("National Instrument 81-106"); while the term "net assets" or "net assets per unit" refers to total equity or net assets attributable to unitholders of the Fund as determined in accordance with International Financial Reporting Standards ("IFRS").

Results of Operations

For the six month period ended June 30, 2018 (the "period"), the Series A units of the Fund returned -0.7%. Fund returns are reported net of all management fees and expenses for all series, unlike the returns of the Fund's benchmark, which is based on the performance of an index that does not pay fees or incur expenses. Returns for other series of the Fund will be similar to Series A units with any difference in performance being primarily due to different management fees, operating expenses and other expenses that are applicable to that particular series. Please see the "Past Performance" section for the performance of the Fund's other series.

The Fund's broad-based benchmarks, the S&P/TSX Composite Index and the FTSE TMX Canada Universe Bond Index, returned 1.9% and 0.6%, respectively, during the same period. In accordance with National Instrument 81-106, we have included a comparison to broad-based indices to help you understand the Fund's performance relative to the general performance of the market, but caution that the Fund's mandate may be significantly different from the indices shown.

The Fund's blended benchmark, 50% S&P/TSX Composite Index and 50% FTSE TMX Canada Universe Bond Index, returned 1.3% during the same period. We have included this comparison, which more closely reflects the market sectors and/or asset classes in

which the Fund invests, to provide a more useful comparative to the performance of the Fund.

The Fund underperformed the blended benchmark due in part to equity security selection within the Materials sectors, an underweight held in Energy and hedging of the U.S. dollar exposure.

The first half of 2018 saw mixed performance for Canadian equities, which was weighed down by periods of volatility and ongoing concerns over the fate of NAFTA and a looming trade war with the U.S. In January, the Bank of Canada raised interest rates by 25 basis points ("bps") but vowed to proceed cautiously given record levels of household debt and uncertainty over trade negotiations. Canadian equities began to lag their global peers as NAFTA talks stalled and U.S. President Donald Trump's protectionist rhetoric began to rattle markets. In March, Canadian equities began to recover slightly as trade talks began to show signs of progress. Energy securities provided a major boost as oil prices broke out to multi-year highs. Although trade tensions re-emerged and continued to weigh on investor sentiment – and the loonie – Canadian equities managed to register modest gains over the latter half of the period. Over the six-month period, Information Technology was the clear performance leader, with Industrials and Real Estate also performing relatively strongly. Utilities and Telecommunication Services were the worst performing sectors, ending the furthest in negative territory.

Despite a strong start to the year, U.S. equities ended the six-month period with only moderate gains, as volatility and mounting trade tensions eventually weighed on investor sentiment. However, strength in the U.S. dollar significantly enhanced the return for Canadian investors. While January began on a positive note, boosted by robust corporate earnings, volatility reasserted itself in February as rekindled fears of rising inflation and a steeper trajectory for rate hikes by the U.S. Federal Reserve raised concerns about corporate profitability. Meanwhile, U.S. President Trump rattled markets with his announcement that the U.S. would impose tariffs on steel and aluminum imports, sparking fears of a global trade war. Despite mounting trade tensions, the U.S. economic outlook remained strong, helped by strong consumer spending, low unemployment and stronger-than-expected corporate earnings. However, trade tensions escalated in May and June as the U.S. implemented \$50 billion in tariffs on Chinese goods and pressed forward with steel and aluminum tariffs against its allies – including Canada, Mexico and the European Union, which retaliated with tariffs of their own. During the period, Information Technology and Consumer Discretionary were strong performers. Consumer Staples and Telecommunication Services ended the furthest in negative territory.

Fixed income markets experienced another period of volatility with yields in both Canada and the U.S. ending the period higher. Central Banks continued to look at reducing balance sheets as the theme of Quantitative Tightening drove much of the market discussion. Within the U.S., the 10-year Treasury rose from 2.41% early in the year peaking at 3.11% mid-May before ending the period at 2.86%. The U.S. Federal Reserve increased the target range for overnight interest rates twice by 25bps in March and June of 2018. Canadian interest rates rose over the period as well.

The 10-year Government of Canada yield spiked as high as 2.52% mid-May before ending the period at 2.17%, dropping off its early summer highs. The Bank of Canada raised rates once in January before pausing during the summer months.

While government yields began selling off in January, risk premiums began to sell off in early February, with the U.S. underperforming Canada, as credit spreads increased throughout the period. In Canada, all long-term segments of the corporate sector along with municipals and provincials posted positive returns. Subsectors among Canadian government bonds, including short-term, mid-term and long-term, all finished with positive returns as well. The modified duration of the overall Canadian fixed income index and the corporate index both remained flat at 7.6 years and 6.3 years, respectively.

Over the period the portfolio moved to a small overweight in equities relative to a combination of fixed income and cash. The allocation to equities was lowered with cash and bonds increasing, though bonds to a lesser extent. While both equities and bonds had a positive impact on returns, equities were the larger contributors. Geographically, the Fund trimmed the allocation to Canada and the U.S. as well as the exposure outside North America, primarily through the United Kingdom. The U.S. was a positive contributor, with Canada having a small but negative impact on returns.

Overall sector weightings saw changes in both the U.S. and Canadian exposure. In the U.S. the Consumer Staples, Materials and Information Technology sectors were decreased while the weighting in Consumer Discretionary and Health Care was increased. In Canada, the Energy, Infrastructure and Real Estate allocation was reduced. The top equity exposures were held in Financials, Information Technology, and Real Estate. Within fixed income the exposure to Canadian and U.S. corporate bonds was reduced and a holding in Scotia Total Return Bond LP rose. A position in Scotia Money Market Fund was added.

On a sector level within equities, Materials was the main detractor to performance with Information Technology a contributor. Fixed income had a small but positive impact. Among equities, notable security contributors included Microsoft, Mastercard and Home Depot. Security detractors were Albemarle Corp, BCE and TransCanada Corp.

The Fund's net asset value decreased by 7.2% to \$202.2 million at June 30, 2018, from \$218.0 million at December 31, 2017. This change was composed of net redemptions of \$13.7 million, investment performance of the Fund of negative \$1.5 million and cash distributions of \$0.6 million. The investment performance of the Fund includes income and expenses which vary year over year. The Fund's income and expenses changed compared to the previous year mainly as a result of fluctuations in average net assets, portfolio activity and changes in the Fund's income earning investments.

Certain series of the Fund, as applicable, may make distributions at a rate determined by the Manager from time to time. If the aggregate amount of distributions in such series exceeds the portion of net income and net realized capital gains allocated to such

series, the excess will constitute a return of capital. The Manager does not believe that the return of capital distributions made by such series of the Fund have a meaningful impact on the Fund's ability to implement its investment strategy or to fulfill its investment objective.

Recent Developments

IFRS 9, Financial Instruments

The Funds have adopted IFRS 9, Financial Instruments in the current reporting period commencing January 1, 2018. The adoption of IFRS 9 has been applied retrospectively and does not result in a change to the classification or measurement of financial instruments, in either the current or prior period.

The impact to the Fund will include additional disclosures related to changes to the classification of certain financial instruments to align with the classifications under IFRS 9. Adoption of the standard does not impact net assets attributable to holders of redeemable units.

Related Party Transactions

The Manager is a wholly-owned subsidiary of The Bank of Nova Scotia ("Scotiabank"). Scotiabank also owns, directly or indirectly, 100% of Scotia Securities Inc. and Tangerine Investment Funds Limited, each a mutual fund dealer, and Scotia Capital Inc. (which includes ScotiaMcLeod and Scotia iTRADE), an investment dealer.

The Manager, on behalf of the Fund, may enter into transactions or arrangements with other members of Scotiabank or certain other companies that are related or connected to the Manager (each a "related party"). All transactions between the Fund and the related parties are in the normal course of business and are carried out at arm's length terms.

The purpose of this section is to provide a brief description of any transaction involving the Fund and a related party.

Management Fees

The Manager is responsible for the day-to-day management and operations of the Fund. Certain series of the Fund pay the Manager a management fee for its services as described in the "Management Fee" section later in this document. The management fee is an annualized rate based on the net asset value of each series of the Fund, accrued daily and paid monthly.

Fixed Administration Fees and Other Fund Costs

The Manager pays the operating expenses of the Fund, other than Other Fund Costs, in exchange for the payment by the Fund of a fixed rate administration fee (the "Fixed Administration Fee") to the Manager with respect to each series of the Fund. The expenses charged to the Fund in respect of the Fixed Administration Fee are disclosed in the Fund's financial statements. The Fixed Administration Fee is equal to a specified percentage of the net asset value of a series, calculated and paid in the same manner as the management fees for the Fund. Further details about

the Fixed Administration Fee can be found in the Fund's most recent simplified prospectus.

In addition, each series of the Fund is responsible for its proportionate share of certain operating expenses ("Other Fund Costs"). Further details about Other Fund Costs can be found in the Fund's most recent simplified prospectus.

The Manager, at its sole discretion, may waive or absorb a portion of a series' expenses. These waivers or absorptions may be terminated at any time without notice.

Related Brokerage Commissions

From time to time, the Fund may enter into portfolio securities transactions with Scotia Capital or other related dealers in whom Scotiabank has a significant interest (a "Related Broker"). These Related Brokers may earn commission or spreads on such transactions, which are made on terms and conditions that are comparable to transactions made with non-related brokers.

During the period, the Fund paid \$6,468 in commissions to Related Brokers.

Distribution Services

Certain registered dealers through which units of the Fund are distributed are related parties to the Fund and the Manager. The Manager may pay to these related parties a trailer commission out of its management fees, representing distribution and servicing fees, based on the amount of assets held in the investors' accounts. These fees are paid on the same basis and at the same rates that the Manager pays to non-affiliated dealers.

Other Fees

The Manager, or its affiliates, may earn fees and spreads in connection with various services provided to, or transactions with, the Fund, such as banking, custody, brokerage, foreign exchange and derivatives transactions. The Manager, or its affiliates, may earn a foreign exchange spread when unitholders switch between series of funds denominated in different currencies.

Independent Review Committee

The Manager has established an independent review committee (the "IRC") in accordance with National Instrument 81-107 – Independent Review Committee for Investment Funds ("NI 81-107") with a mandate to review and provide recommendations or approval, as required, on conflict of interest matters referred to it by the Manager on behalf of the Fund. The IRC is responsible for overseeing the Manager's decisions in situations where the Manager is faced with any present or perceived conflicts of interest, all in accordance with NI 81-107.

The IRC may also approve certain mergers between the Fund and other funds, and any change of the auditor of the Fund. Subject to any corporate and securities law requirements, no securityholder approval will be obtained in such circumstances, but you will be sent a written notice at least 60 days before the effective date of any such transaction or change of auditor. In

certain circumstances, securityholder approval may be required to approve certain mergers.

The IRC has five members, Carol S. Perry (Chair), Stephen J. Griggs, Simon Hitzig, Heather A. T. Hunter and Jennifer L. Witterick, each of whom is independent of the Manager. On April 30, 2018, Brahm Gelfand and D. Murray Paton resigned as members of the IRC. On May 15, 2018, the IRC appointed Mr. Griggs and Ms. Hunter as members.

The IRC prepares and files a report to the securityholders each fiscal year that describes the IRC and its activities for securityholders as well as contains a complete list of the standing instructions. These standing instructions enable the Manager to act in a particular conflict of interest matter on a continuing basis provided the Manager complies with its policies and procedures established to address that conflict of interest matter and reports periodically to the IRC on the matter. This report to the securityholders is available on the Manager's website or, at no cost, by contacting the Manager.

The compensation and other reasonable expenses of the IRC will be paid out of the assets of the Fund as well as out of the assets of the other investment funds for which the IRC may act as the independent review committee. The main components of compensation are an annual retainer and a fee for each committee meeting attended. The chair of the IRC is entitled to an additional fee. Expenses of the IRC may include premiums for insurance coverage, travel expenses and reasonable out-of-pocket expenses.

The Fund received the following standing instructions from the IRC with respect to related party transactions:

- Paying brokerage commissions and spreads to a related party for effecting security transactions on an agency and principal basis on behalf of the Fund;

- Purchases or sales of securities of an issuer from or to another investment fund managed by the Manager;
- Investments in the securities of issuers for which a related underwriter acted as an underwriter during the distribution of such securities and the 60-day period following the completion of such distribution;
- Executing foreign exchange transactions with a related party on behalf of the Fund;
- Purchases of securities of a related party;
- Entering into over-the-counter derivatives on behalf of the Fund with a related party;
- Outsourcing products and services to related parties which can be charged to the Fund;
- Acquisition of prohibited securities as defined by securities regulations;
- Trading in mortgages with a related party.

The Manager is required to advise the IRC of any breach of a condition of the standing instructions. The standing instructions require, among other things, that the investment decision in respect to a related party transaction: (a) is made by the Manager free from any influence by an entity related to the Manager and without taking into account any consideration to any associate or affiliate of the Manager; (b) represents the business judgment of the Manager uninfluenced by considerations other than the best interests of the Fund; and (c) is made in compliance with the Manager's written policies and procedures. Transactions made by the Manager under the standing instructions are subsequently reviewed by the IRC to monitor compliance.

The Fund relied on IRC standing instructions regarding related party transactions during the period.

⁽³⁾ The trading expense ratio represents total commissions and other portfolio transaction costs of the Fund and the underlying funds, where applicable, expressed as an annualized percentage of daily average net asset value of the Fund during the period.

⁽⁴⁾ The Fund's portfolio turnover rate indicates how actively the Fund's portfolio advisor manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the period. The higher a fund's portfolio turnover rate in a period, the greater the trading costs payable by the fund in the period, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund.

Management Fees

The management fee is an annualized rate based on the net asset value of each series of the Fund, accrued daily and paid monthly. The management fees cover the costs of managing the Fund, arranging for investment analysis, recommendations and investment decision making for the Fund, arranging for distribution of the Fund, marketing and promotion of the Fund and providing or arranging for other services.

The breakdown of services received in consideration of management fees for each series, as a percentage of the management fees, are as follows:

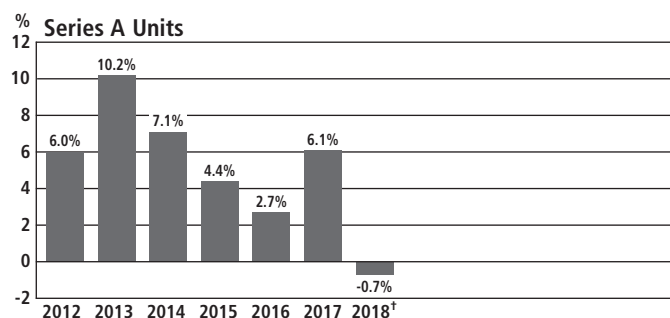

Past Performance

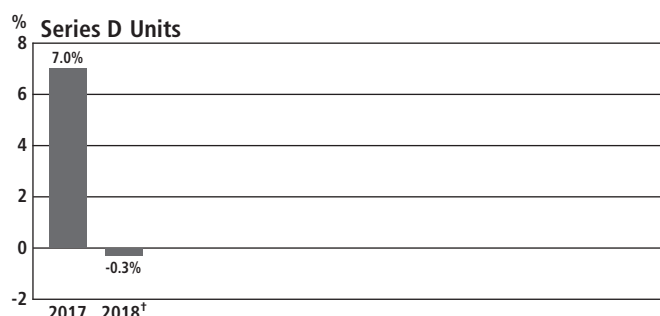

Year-by-Year Returns

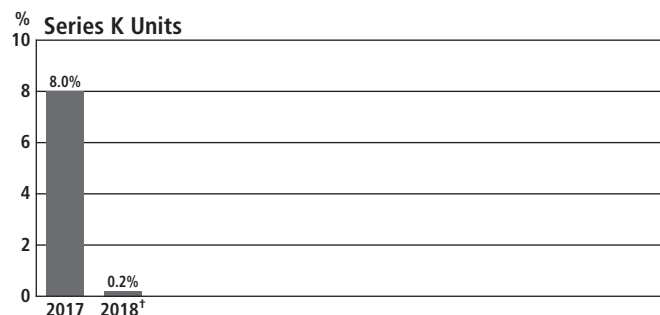

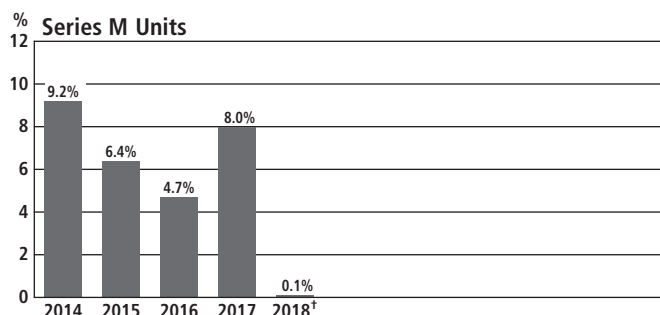
