1832 Asset Management L.P. is the manager (the "Manager") of the fund. In this document, "we", "us", "our" and the "Manager" refer to 1832 Asset Management L.P. and the "Fund" refers to 1832 AM Emerging Markets Equity Pool.

The term "net asset value" or "net asset value per unit" in this document refers to the net asset value determined in accordance with Part 14 of National Instrument 81-106 – Investment Fund Continuous Disclosure ("National Instrument 81-106"); while the term "net assets" or "net assets per unit" refers to total equity or net assets attributable to unitholders of the Fund as determined in accordance with International Financial Reporting Standards ("IFRS").

Results of Operations

For the six month period ended June 30, 2022 (the "period"), the Series I units of the Fund generated a total return of -20.8% . Fund returns are reported net of all management fees and expenses, unlike the returns of the Fund's benchmark, which is based on the performance of an index that does not pay fees or incur expenses.

The Fund's broad-based benchmark, the MSCI Emerging Markets Index (C\$), returned -16.1% during the same period. In accordance with National Instrument 81-106, we have included a comparison to this broad-based index to help you understand the Fund's performance relative to the general performance of the market.

Early in the period, the Russia-Ukraine conflict, rapidly rising commodity prices, inflationary pressures and increasing interest rates contributed to weakness across most equity markets. Economic growth slowed in line with the rise in interest rates.

Growth stocks continued to underperform value stocks, but after several challenging quarters, the outlook for growth stocks began to improve. Policy-driven inflation and other factors that had negatively affected growth stocks began to ease as the U.S. Federal Reserve Board mirrored many other global central banks,

aggressively tightening monetary policy. By the end of the period, it appeared that several key inflationary contributors were beginning to peak. Similarly, several widely followed economic measures moved lower from the peaks experienced during the period.

Later in the period, markets became increasingly focused on the prospect of a recession. The best-performing sectors in the emerging markets included Utilities, Real Estate and Financials sectors, while Information Technology, Health Care and Communication Services underperformed.

The Fund underperformed the broad-based benchmark primarily as a result of stock selection, particularly in the Information Technology, Financials and Utilities sectors.

An overweight position in the Information Technology sector also detracted from performance, as did stock selection in China and Taiwan. Top individual detractors from performance included Taiwan Semiconductor Manufacturing Co. Ltd. and Lukoil PJSC. Taiwan Semiconductor struggled with weaker demand for Chinese smartphones, as chip fabrication for these phones is a major contributor to its revenue. There were also concerns that broader economic challenges could weaken demand for semiconductors. Shares of Lukoil declined alongside other Russian stocks amid the ongoing conflict in Ukraine.

Overweight exposure to the Financials and Industrials sectors contributed to performance, as did stock selection in Communication Services. Underweight exposure to Russia also contributed to performance. Top individual contributors included Travelsky Technology Ltd., BYD Co. Ltd. and PTT Exploration and Production PCL. Travelsky shares rose in response to relaxed quarantine requirements for travellers and eased pandemic-related lockdowns in some parts of China. The company has a solid balance sheet with a net cash position to help it weather any further travel disruptions. BYD reported that sales volume reached new record levels and indicated upside to its full-year volume targets. PTT benefited from rising energy prices across the globe.

During the period, we added BDO Unibank Inc., LG Energy Solution Ltd., Sea Ltd. and Baidu Inc. to the Fund. BDO is the largest universal bank in the Philippines and offers attractive exposure to the country's long-term growth opportunities in the Financials sector. LG Energy Solutions is a leading electric vehicle ("EV") battery supplier controlling over 50% of the market share outside of China, which provides focused exposure to long-term EV growth. Sea is the largest internet conglomerate in Southeast Asia and has achieved substantial growth across numerous emerging markets in recent years. We added Baidu to increase the Fund's exposure to large Chinese internet platforms, based on easing regulatory challenges and the potential for positive margin revisions driven by cost reductions.

We increased the Fund's exposure to holdings with more defensive characteristics in response to the increasingly uncertain economic background. We also increased exposure to telecommunications firms, such as PT Telkom Indonesia (Persero) TBK, for their defensive earnings profiles and improving competitive environments in select geographies.

Exposure to Information Technology services companies, including Endava PLC and TE Connectivity Ltd., was eliminated based on wage-related input cost pressures and the potential risk to future revenue growth caused by economic uncertainty. We also sold Russian holding Lukoil based on geopolitical risk. Among the positions trimmed were China Merchants Bank Co. Ltd. and Taiwan Semiconductor. The unexpected removal of China Merchants Bank's CEO raised questions about its risk profile. We trimmed Taiwan Semiconductor as a result of declining consumer electronic device demand and the associated demand for chips required by those devices.

The Fund's net asset value decreased to \$283.2 million at June 30, 2022, from \$357.1 million at December 31, 2021. This change was composed of net sales of \$0.6 million and investment performance of negative \$74.5 million. The investment performance of the Fund includes income and expenses which vary year over year. The Fund's income and expenses changed compared to the previous year mainly as a result of fluctuations in average net assets, portfolio activity and changes in the Fund's income earning investments.

The Fund may make distributions at a rate determined by the Manager from time to time. If the aggregate amount of distributions exceeds the portion of net income and net realized capital gains, the excess will constitute a return of capital. The Manager does not believe that the return of capital distributions made by the Fund have a meaningful impact on the Fund's ability to implement its investment strategy or to fulfill its investment objective.

Recent Developments

There have been no recent developments that have affected, or are likely to materially affect the Fund.

Related Party Transactions

The Manager is a wholly-owned subsidiary of The Bank of Nova Scotia ("Scotiabank"). Scotiabank also owns, directly or indirectly, 100% of Scotia Securities Inc., a mutual fund dealer, and Scotia Capital Inc. (which includes ScotiaMcLeod and Scotia iTRADE), an investment dealer.

The Manager, on behalf of the Fund, may enter into transactions or arrangements with other members of Scotiabank or certain other companies that are related or connected to the Manager (each a "related party"). All transactions between the Fund and the related parties are in the normal course of business and are carried out at arm's length terms.

The purpose of this section is to provide a brief description of any transaction involving the Fund and a related party.

Fixed Administration Fees and Fund Costs

The Manager pays the operating expenses of the Fund, other than Fund Costs, in exchange for the payment by the Fund of a fixed rate administration fee (the "Fixed Administration Fee") to the Manager with respect to each series of the Fund. The expenses

charged to the Fund in respect of the Fixed Administration Fee are disclosed in the Fund's financial statements. The Fixed Administration Fee is equal to a specified percentage of the net asset value of a series, calculated and paid in the same manner as the management fees for the Fund. Further details about the Fixed Administration Fee can be found in the Fund's most recent simplified prospectus.

In addition, each series of the Fund is responsible for its proportionate share of certain operating expenses ("Fund Costs"). Further details about Fund Costs can be found in the Fund's most recent simplified prospectus.

The Manager, at its sole discretion, may waive or absorb a portion of a series' expenses. These waivers or absorptions may be terminated at any time without notice.

Other Fees

The Manager, or its affiliates, may earn fees and spreads in connection with various services provided to, or transactions with, the Fund, such as banking, custody, brokerage, foreign exchange or derivatives transactions. The Manager, or its affiliates, may earn a foreign exchange spread when unitholders switch between series of funds denominated in different currencies.

Independent Review Committee

The Manager has established an independent review committee (the "IRC") in accordance with National Instrument 81-107 – Independent Review Committee for Investment Funds ("NI 81-107") with a mandate to review and provide recommendations or approval, as required, on conflict of interest matters referred to it by the Manager on behalf of the Fund. The IRC is responsible for overseeing the Manager's decisions in situations where the Manager is faced with any present or perceived conflicts of interest, all in accordance with NI 81-107.

The IRC may also approve certain mergers between the Fund and other funds, and any change of the auditor of the Fund. Subject to any corporate and securities law requirements, no securityholder approval will be obtained in such circumstances, but you will be sent a written notice at least 60 days before the effective date of any such transaction or change of auditor. In certain circumstances, securityholder approval may be required to approve certain mergers.

The IRC has five members, Stephen J. Griggs (Chair), Steven Donald, Simon Hitzig, Heather A. T. Hunter and Jennifer L. Witterick, each of whom is independent of the Manager.

The IRC prepares and files a report to the securityholders each fiscal year that describes the IRC and its activities for securityholders as well as contains a complete list of the standing instructions. These standing instructions enable the Manager to act in a particular conflict of interest matter on a continuing basis provided the Manager complies with its policies and procedures established to address that conflict of interest matter and reports periodically to the IRC on the matter. This report to the securityholders is available on the Manager's website or, at no cost, by contacting the Manager.

The compensation and other reasonable expenses of the IRC will be paid out of the assets of the Fund as well as out of the assets of the other investment funds for which the IRC may act as the independent review committee. Each member of the IRC receives an annual retainer of \$62,000 (\$77,000 for the Chair), plus expenses for each meeting. The fees and expenses, plus associated legal costs, are allocated among all of the funds managed by the Manager for which the IRC acts as the independent review committee in a manner that is considered by the Manager to be fair and reasonable. The main component of compensation is an annual retainer fee. Prior to November 1, 2021, each IRC member also received a fee for each committee meeting attended. Expenses of the IRC may include premiums for insurance coverage, travel expenses and reasonable out-of-pocket expenses.

The Manager, in respect of the Fund, received the following standing instructions from the IRC with respect to related party transactions:

- Paying brokerage commissions and spreads to a related party for effecting security transactions on an agency and principal basis on behalf of the Fund;
- Purchases or sales of securities of an issuer from or to another investment fund managed by the Manager;
- Investments in the securities of issuers for which a related underwriter acted as an underwriter during the distribution of such securities and the 60-day period following the completion of such distribution;
- Executing foreign exchange transactions with a related party on behalf of the Fund;
- Purchases of securities of a related party;
- Entering into over-the-counter derivatives on behalf of the Fund with a related party;
- Outsourcing products and services to related parties which can be charged to the Fund;
- Acquisition of prohibited securities as defined by securities regulations;
- Trading in mortgages with a related party;
- Entering into a designated broker agreement with a related party; and
- Entering into a prime broker agreement with a related party.

The Manager is required to advise the IRC of any breach of a condition of the standing instructions. The standing instructions require, among other things, that the investment decision in respect to a related party transaction: (a) is made by the Manager free from any influence by an entity related to the Manager and without taking into account any consideration to any associate or affiliate of the Manager; (b) represents the business judgment of the Manager uninfluenced by considerations other than the best interests of the Fund; and (c) is made in compliance with the Manager's written policies and procedures. Transactions made by the Manager under the standing instructions are subsequently reviewed by the IRC to monitor compliance.

The Manager, in respect of the Fund, did not rely on IRC standing instructions regarding related party transactions during the period.

Financial Highlights

The information on the following tables is based on prescribed regulations and as a result, is not expected to add across due to the increase (decrease) in net assets from operations being based on average units outstanding during the period and all other numbers being based on actual units outstanding at the relevant point in time. ⁽³⁾ The trading expense ratio represents total commissions and other portfolio transaction costs, short borrowing costs and interest on leverage of the Fund and the underlying funds, where applicable, expressed as an annualized percentage of daily average net asset value of the Fund during the period.

⁽⁴⁾ The Fund's portfolio turnover rate indicates how actively the Fund's portfolio advisor manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the period. The higher a fund's portfolio turnover rate in a period, the greater the trading costs payable by the fund in the period, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund.

Management Fees

The Manager is not entitled to a management fee payable by the Fund in respect of Series I units. The management fee is negotiable and paid by unitholders directly to the Manager.

Past Performance

The following shows the past performance for each series and will not necessarily indicate how the Fund will perform in the future. The information shown assumes that all distributions made by each series of the Fund in the periods shown were reinvested in

additional units of the relevant series. In addition, the information does not take into account sales, redemption, distribution or other optional charges that would have reduced returns or performance.
