1832 Asset Management L.P. is the manager (the "Manager") of the fund. In this document, "we", "us", "our" and the "Manager" refer to 1832 Asset Management L.P. and the "Fund" refers to Scotia Canadian Growth Fund.

The term "net asset value" or "net asset value per unit" in this document refers to the net asset value determined in accordance with Part 14 of National Instrument 81-106 – Investment Fund Continuous Disclosure ("National Instrument 81-106"); while the term "net assets" or "net assets per unit" refers to total equity or net assets attributable to unitholders of the Fund as determined in accordance with International Financial Reporting Standards ("IFRS").

Results of Operations

For the six month period ended June 30, 2022 (the "period"), the Series A units of the Fund generated a total return of – 18.2%. Fund returns are reported net of all management fees and expenses for all series, unlike the returns of the Fund's benchmark, which is based on the performance of an index that does not pay fees or incur expenses. Returns for other series of the Fund will be similar to Series A with any difference in performance being primarily due to different management fees, operating expenses and other expenses that are applicable to that particular series. Please see the "Past Performance" section for the performance of the Fund's other series.

The Fund's broad-based benchmark, the S&P/TSX Composite Index, returned – 9.9% during the same period. In accordance with National Instrument 81-106, we have included a comparison to this broad-based index to help you understand the Fund's performance relative to the general performance of the market.

The Fund underperformed the broad-based benchmark due in part to an underweight allocation to the Energy sector and security selection in Communication Services holdings. This was partly offset by positive security selection in Financials holdings.

The Canadian equity market ended the 6-month period in negative territory as the S&P/TSX Composite Index returned -9.9% . The first half of 2022 can be summed up in one word: volatility. As we began lifting Covid-19 lockdown restrictions and reopening the economy, we witnessed major global supply chain issues causing rapid inflation. This was further compounded by the Russia-Ukraine military conflict. The reaction to these events was one of severity in the capital markets.

The effects associated with reopening the economy resulted in greater demand of goods, rising commodity prices, higher input costs, supply chain disruptions, and lifting inflation to its highest point in almost 40 years. In May, inflation reached 7.7% on an annualized basis. Energy prices have soared: oil prices increased by 350% from April 2020 to April 2022, the largest increase for any two-year period since the early 1970s. Furthermore, coal and natural gas prices reached historical highs.

As a counterpoint, the Bank of Canada (BoC) aggressively increased interest rates three times since March. The overnight loan rate, its key interest rate, has risen from 0.25% in March to 1.50% at the end of the first half of the year. More rate hikes are expected in the second half, as the BoC has stated its main goal is to tame inflation and stop it before becoming entrenched in the economy.

To contend with these challenges, many companies plan to increase spending on equipment to improve productivity, and hiring intentions also remain widespread. The BoC's Business Outlook Survey showed firms remain optimistic about future sales growth, but an increasing number of businesses expect growth to decelerate over the next 12 months as demand normalizes.

Nine of the 11 GICS (Global Industry Classification Standard) sectors posted negative returns over the 6-month period. The best performing sectors were Energy ($+26.2\%$), Utilities ($+1.3\%$), and Communication Services (-0.8%). The worst performing sectors were Information Technology (-55.3%), Health Care (-53.9%), and Real Estate (-21.7%).

Over the period, the Canadian dollar strengthened against most major currencies, save the U.S. dollar.

The U.S. equity market ended the 6-month period in negative territory as the S&P 500 Index (\$C) returned -18.5% . The first half of 2022 can be summed up in one word: volatility. The Russia-Ukraine military conflict caused a global shock in capital markets with equities declining and bond yields rising. Commodity prices soared given Russia is a key producer of several important commodities including oil, gas, and wheat. This contributed to a further surge in inflation as well as supply chain disruption.

Inflation rose to a 40-year high, the consumer price index (CPI), a measure of inflation, rose 8.6% annually in May 2022. Energy prices have soared: oil prices increased by 350% from April 2020 to April 2022, the largest increase for any two-year period since the early 1970s. Furthermore, coal and natural gas prices reached historical highs.

The U.S. Federal Reserve (Fed) increased the Fed funds rate, its key interest rate, three times (0.25% in March, 0.50% in May, and

0.75% in June) in the first half of 2022 from 0.08% to 1.58% . The last rate hike in June (0.75%) was the largest rate increase since 1994. On the bright side, the labour market endures as unemployment remains at 3.6% putting it near a 50-year low. Nevertheless, the Fed remains hawkish and signalled "inflation is the number one danger to the overall health" of the economy, which implies they are willing to accept a slowdown to economic growth in order to cool inflation.

Nine of the 11 GICS (Global Industry Classification Standard) sectors posted negative returns over the 6-month period. The best performing sectors were Energy ($+34.0\%$), Utilities ($+1.1\%$), and Consumer Staples (-4.0%). The worst performing sectors were Consumer Discretionary (-31.7%), Communication Services (-29.0%), and Information Technology (-25.7%).

Over the period, the U.S. dollar strengthened against most major currencies including the Euro currency, British pound, Japanese yen and the Canadian dollar.

During the period, the weighting to Canada increased, while the U.S. fell. Geographically both regions had a negative contribution to returns with the U.S. having the greatest impact on performance.

The sector exposure within the Fund is diversified, with Financials, Information Technology, and Industrials representing the top allocations. Overall, most sector allocations saw marginal changes. However, over the period the allocation to Financials and Energy were increased, while holdings in Information Technology and Communication Services were reduced. The allocation to Energy was the top contributor to performance, while holdings in Information Technology, Communication Services, and Consumer Discretionary detracted from performance at a sector level. Individual securities which had the most positive impact included Suncor Energy Incorporated, Intact Financial Corporation, and Dollarama Incorporated. Holdings in Nvidia Corporation, Sherwin-Williams Company, and Alphabet Incorporated were the largest detractors to performance.

The Fund's net asset value decreased to \$1,115.1 million at June 30, 2022, from \$1,363.6 million at December 31, 2021. This change was composed of net redemptions of \$7.8 million and investment performance of negative \$240.7 million. The investment performance of the Fund includes income and expenses which vary year over year. The Fund's income and expenses changed compared to the previous year mainly as a result of fluctuations in average net assets, portfolio activity and changes in the Fund's income earning investments.

Certain series of the Fund, as applicable, may make distributions at a rate determined by the Manager from time to time. If the aggregate amount of distributions in such series exceeds the portion of net income and net realized capital gains allocated to such series, the excess will constitute a return of capital. The Manager does not believe that the return of capital distributions made by such series of the Fund have a meaningful impact on the Fund's ability to implement its investment strategy or to fulfill its investment objective.

Recent Developments

There have been no recent developments that have affected, or are likely to materially affect the Fund.

Related Party Transactions

The Manager is a wholly-owned subsidiary of The Bank of Nova Scotia (“Scotiabank”). Scotiabank also owns, directly or indirectly, 100% of Scotia Securities Inc., a mutual fund dealer, and Scotia Capital Inc. (which includes ScotiaMcLeod and Scotia iTRADE), an investment dealer.

The Manager, on behalf of the Fund, may enter into transactions or arrangements with other members of Scotiabank or certain other companies that are related or connected to the Manager (each a “related party”). All transactions between the Fund and the related parties are in the normal course of business and are carried out at arm’s length terms.

The purpose of this section is to provide a brief description of any transaction involving the Fund and a related party.

Management Fees

The Manager is responsible for the day-to-day management and operations of the Fund. Certain series of the Fund pay the Manager a management fee for its services as described in the “Management Fee” section later in this document. The management fee is an annualized rate based on the net asset value of each series of the Fund, accrued daily and paid monthly.

Fixed Administration Fees and Fund Costs

The Manager pays the operating expenses of the Fund, other than Fund Costs, in exchange for the payment by the Fund of a fixed rate administration fee (the “Fixed Administration Fee”) to the Manager with respect to each series of the Fund. The expenses charged to the Fund in respect of the Fixed Administration Fee are disclosed in the Fund’s financial statements. The Fixed Administration Fee is equal to a specified percentage of the net asset value of a series, calculated and paid in the same manner as the management fees for the Fund. Further details about the Fixed Administration Fee can be found in the Fund’s most recent simplified prospectus.

In addition, each series of the Fund is responsible for its proportionate share of certain operating expenses (“Fund Costs”). Further details about Fund Costs can be found in the Fund’s most recent simplified prospectus.

The Manager, at its sole discretion, may waive or absorb a portion of a series’ expenses. These waivers or absorptions may be terminated at any time without notice.

Related Brokerage Commissions

From time to time, the Fund may enter into portfolio securities transactions with Scotia Capital Inc. or other related dealers in whom Scotiabank has a significant interest (a “Related Broker”). These Related Brokers may earn commission or spreads on such

transactions, which are made on terms and conditions that are comparable to transactions made with non-related brokers.

During the period, the Fund paid \$24,957 in commissions to Related Brokers.

Distribution Services

Certain registered dealers through which units of the Fund are distributed are related parties to the Fund and the Manager. The Manager may pay a trailing commission, which is negotiated with dealers, to dealers for their financial advisors in respect of the assets of their clients invested in securities of the Fund. The Manager, during the period, could also pay trailing commissions to dealers for securities purchased or held through discount brokerage accounts.

Other Fees

The Manager, or its affiliates, may earn fees and spreads in connection with various services provided to, or transactions with, the Fund, such as banking, custody, brokerage, foreign exchange or derivatives transactions. The Manager, or its affiliates, may earn a foreign exchange spread when unitholders switch between series of funds denominated in different currencies.

Independent Review Committee

The Manager has established an independent review committee (the “IRC”) in accordance with National Instrument 81-107 – Independent Review Committee for Investment Funds (“NI 81-107”) with a mandate to review and provide recommendations or approval, as required, on conflict of interest matters referred to it by the Manager on behalf of the Fund. The IRC is responsible for overseeing the Manager’s decisions in situations where the Manager is faced with any present or perceived conflicts of interest, all in accordance with NI 81-107.

The IRC may also approve certain mergers between the Fund and other funds, and any change of the auditor of the Fund. Subject to any corporate and securities law requirements, no securityholder approval will be obtained in such circumstances, but you will be sent a written notice at least 60 days before the effective date of any such transaction or change of auditor. In certain circumstances, securityholder approval may be required to approve certain mergers.

The IRC has five members, Stephen J. Griggs (Chair), Steven Donald, Simon Hitzig, Heather A. T. Hunter and Jennifer L. Witterick, each of whom is independent of the Manager.

The IRC prepares and files a report to the securityholders each fiscal year that describes the IRC and its activities for securityholders as well as contains a complete list of the standing instructions. These standing instructions enable the Manager to act in a particular conflict of interest matter on a continuing basis provided the Manager complies with its policies and procedures established to address that conflict of interest matter and reports periodically to the IRC on the matter. This report to the securityholders is available on the Manager’s website or, at no cost, by contacting the Manager.

The compensation and other reasonable expenses of the IRC will be paid out of the assets of the Fund as well as out of the assets of the other investment funds for which the IRC may act as the independent review committee. Each member of the IRC receives an annual retainer of \$62,000 (\$77,000 for the Chair), plus expenses for each meeting. The fees and expenses, plus associated legal costs, are allocated among all of the funds managed by the Manager for which the IRC acts as the independent review committee in a manner that is considered by the Manager to be fair and reasonable. The main component of compensation is an annual retainer fee. Prior to November 1, 2021, each IRC member also received a fee for each committee meeting attended. Expenses of the IRC may include premiums for insurance coverage, travel expenses and reasonable out-of-pocket expenses.

The Manager, in respect of the Fund, received the following standing instructions from the IRC with respect to related party transactions:

- Paying brokerage commissions and spreads to a related party for effecting security transactions on an agency and principal basis on behalf of the Fund;
- Purchases or sales of securities of an issuer from or to another investment fund managed by the Manager;
- Investments in the securities of issuers for which a related underwriter acted as an underwriter during the distribution of such securities and the 60-day period following the completion of such distribution;
- Executing foreign exchange transactions with a related party on behalf of the Fund;

Financial Highlights

- Outsourcing products and services to related parties which can be charged to the Fund;
- Acquisition of prohibited securities as defined by securities regulations;
- Trading in mortgages with a related party;
- Entering into a designated broker agreement with a related party; and
- Entering into a prime broker agreement with a related party.

The Manager is required to advise the IRC of any breach of a condition of the standing instructions. The standing instructions require, among other things, that the investment decision in respect to a related party transaction: (a) is made by the Manager free from any influence by an entity related to the Manager and without taking into account any consideration to any associate or affiliate of the Manager; (b) represents the business judgment of the Manager uninfluenced by considerations other than the best interests of the Fund; and (c) is made in compliance with the Manager's written policies and procedures. Transactions made by the Manager under the standing instructions are subsequently reviewed by the IRC to monitor compliance.

The Manager, in respect of the Fund, relied on IRC standing instructions regarding related party transactions during the period.

⁽³⁾ The trading expense ratio represents total commissions and other portfolio transaction costs, short borrowing costs and interest on leverage of the Fund and the underlying funds, where applicable, expressed as an annualized percentage of daily average net asset value of the Fund during the period.

⁽⁴⁾ The Fund's portfolio turnover rate indicates how actively the Fund's portfolio advisor manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the period. The higher a fund's portfolio turnover rate in a period, the greater the trading costs payable by the fund in the period, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund.

Management Fees

The management fee is an annualized rate based on the net asset value of each series of the Fund, accrued daily and paid monthly. The management fees cover the costs of managing the Fund, arranging for investment analysis, recommendations and investment decision making for the Fund, arranging for distribution of the Fund, marketing and promotion of the Fund and providing or arranging for other services.

The breakdown of services received in consideration of management fees for each series, as a percentage of the management fees, are as follows:

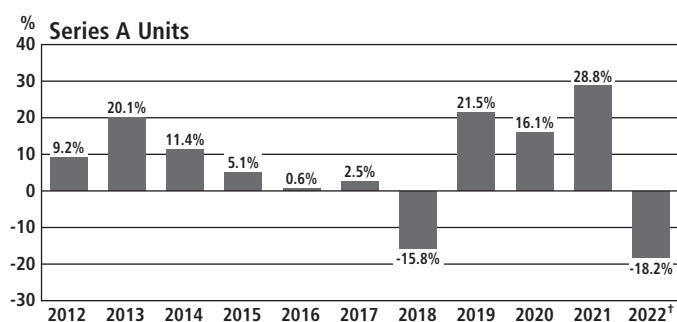

Past Performance

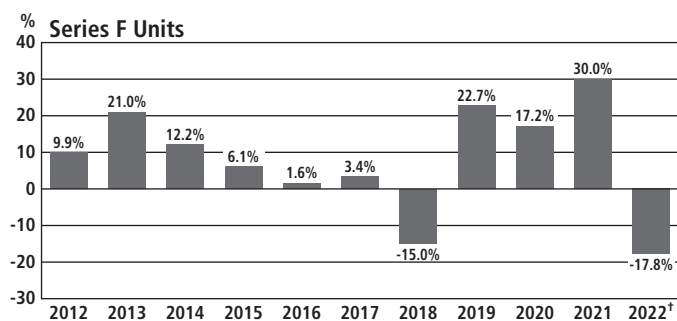

Year-By-Year Returns

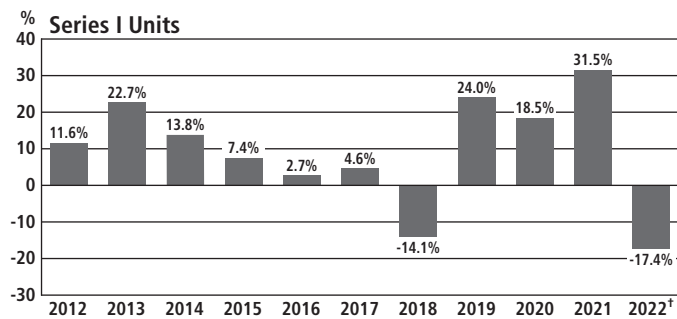
