1832 Asset Management L.P. is the manager (the "Manager") of the fund. In this document, "we", "us", "our" and the "Manager" refer to 1832 Asset Management L.P. and the "Fund" refers to Scotia Wealth Emerging Markets Pool.

The term "net asset value" or "net asset value per unit" in this document refers to the net asset value determined in accordance with Part 14 of National Instrument 81-106 – Investment Fund Continuous Disclosure ("National Instrument 81-106"); while the term "net assets" or "net assets per unit" refers to total equity or net assets attributable to unitholders of the Fund as determined in accordance with International Financial Reporting Standards ("IFRS").

Results of Operations

For the six month period ended June 30, 2022 (the "period"), the Pinnacle Series units of the Fund generated a total return of – 18.8%. Fund returns are reported net of all management fees and expenses for all series, unlike the returns of the Fund's benchmark, which is based on the performance of an index that does not pay fees or incur expenses. Returns for other series of the Fund will be similar to Pinnacle Series with any difference in performance being primarily due to different management fees, operating expenses and other expenses that are applicable to that particular series. Please see the "Past Performance" section for the performance of the Fund's other series.

The Fund's broad-based benchmark, the MSCI Emerging Markets Index (C\$), returned – 16.1% during the same period. In accordance with National Instrument 81-106, we have included a comparison to this broad-based index to help you understand the Fund's performance relative to the general performance of the market.

Emerging markets equities declined during the first quarter of 2022, partly due to the Russia-Ukraine conflict. In addition, China's largest COVID-19 outbreak since the onset of the pandemic prompted new lockdowns that threatened to substantially disrupt

supply chains. Latin America was the top-performing region, followed by Asia and Europe, the Middle East, and Africa (“EMEA”). The conflict in Ukraine drove energy, grain and metal prices sharply higher, which benefited Latin American economies that rely heavily on commodity exports. Asian equities struggled with a sharp decline as Chinese markets suffered precariously in response to the conflict in Ukraine. China’s central bank continued to shift toward a more accommodative policy stance to combat slowing economic growth, and the government pledged to support the economy and financial markets. The EMEA region declined, affected by Russia’s removal from major equity indices following severe foreign sanctions.

In the second quarter, emerging markets equities declined as the global economy decelerated amid elevated geopolitical tensions, ongoing supply-chain disruptions and sharply higher food and energy prices. Tighter global monetary policy also weighed on investor sentiment. Although all regions were negative, Asia was the top-performing region for the quarter, followed by EMEA and Latin America. Asian equities fell, with broad risk-averse sentiment and expectations of higher inflation pressuring most countries. China’s economic activity strengthened, but policymakers reaffirmed they would maintain the country’s zero-COVID strategy, dampening its economic outlook. Several EMEA countries struggled with the impact of the ongoing conflict in Ukraine. Latin American equities declined sharply amid political and economic challenges.

The Fund underperformed the benchmark primarily as a result of security selection in the Energy, Information Technology and Communication Services sectors.

At the regional level, overweight exposure to Russia and stock selection in Taiwan detracted from the Fund’s performance. Top individual detractors included overweight positions in Gazprom PJSC, Lukoil PJSC and Yandex NV. All three stocks declined sharply as increasing Western sanctions against Russia eliminated almost U.S. \$200 billion in stock market value. These stocks were subsequently written down nearly 100% along with most other Russian equities.

Stock selection within the Materials, Financials and Industrials sectors contributed to performance, as did underweight exposure to South Korea and stock selection in Thailand and India. Top individual contributors included an overweight position in KE Holdings Inc., as well as holdings in AIA Group Ltd. and Kasikornbank PCL, neither of which are held in the benchmark. Shares of KE Holdings rose after the company reported first-quarter earnings and announced a buyback program of up to US\$1 billion. The company is taking measures to optimize its cost structure, continues to take market share, is growing faster than the industry, and appears well positioned for an economic recovery. Shares of insurance provider AIA rose after the company reported that total weighted premium income had increased over the previous year while annualized new premiums declined. Shares of Thai bank Kasikornbank rose on optimism that reopening the economy would accelerate the bank’s recovery. Kasikornbank continues to steadily take market share from

competitors, given its leading technology and digitalization position compared to its peers.

During the period, we added U.K.-based multinational bank Standard Chartered PLC to the Fund. The bank is rapidly benefiting from rising interest rates, and it posted strong first-quarter results. Revenue growth and investor sentiment is improving despite the company’s strong cost discipline.

We increased the Fund’s position in Reliance Industries Ltd., an Indian energy conglomerate that focuses on hydrocarbon exploration and petroleum refining and marketing. We believe Reliance will benefit from rising energy prices more than the market expects, and its other business segments can help offset its cyclical energy business.

We eliminated the Fund’s position in Taiwanese financial holding company E.Sun Financial Holding Co. Ltd. on share price strength in favour of more compelling opportunities. A holding in Chinese battery manufacturer Contemporary Amperex Technology Co. Ltd. was trimmed to reduce the Fund’s exposure to electric vehicle and battery-related stocks amid the Russia-Ukraine conflict. Russia is a leading provider of high-grade nickel, which is a substantial component of electric vehicle battery costs.

The Fund’s net asset value decreased to \$57.8 million at June 30, 2022, from \$69.9 million at December 31, 2021. This change was composed of net sales of \$1.2 million and investment performance of negative \$13.3 million. The investment performance of the Fund includes income and expenses which vary year over year. The Fund’s income and expenses changed compared to the previous year mainly as a result of fluctuations in average net assets, portfolio activity and changes in the Fund’s income earning investments.

Certain series of the Fund, as applicable, may make distributions at a rate determined by the Manager from time to time. If the aggregate amount of distributions in such series exceeds the portion of net income and net realized capital gains allocated to such series, the excess will constitute a return of capital. The Manager does not believe that the return of capital distributions made by such series of the Fund have a meaningful impact on the Fund’s ability to implement its investment strategy or to fulfill its investment objective.

Recent Developments

Russia and Ukraine Conflict

Since the start of the conflict in late February 2022, Russian securities have declined in value due to economic sanctions placed on Russia and certain of its citizens. Price volatility, trading restrictions, including the potential for extended halting of Russian market trading, and general default risk related to Russian securities held by the Fund have increased substantially since December 31, 2021. The Manager will continue to monitor the situation and the effects on the Fund.

Related Party Transactions

The Manager is a wholly-owned subsidiary of The Bank of Nova Scotia (“Scotiabank”). Scotiabank also owns, directly or indirectly, 100% of Scotia Securities Inc., a mutual fund dealer, and Scotia Capital Inc. (which includes ScotiaMcLeod and Scotia iTRADE), an investment dealer.

The Manager, on behalf of the Fund, may enter into transactions or arrangements with other members of Scotiabank or certain other companies that are related or connected to the Manager (each a “related party”). All transactions between the Fund and the related parties are in the normal course of business and are carried out at arm’s length terms.

The purpose of this section is to provide a brief description of any transaction involving the Fund and a related party.

Management Fees

The Manager is responsible for the day-to-day management and operations of the Fund. Certain series of the Fund pay the Manager a management fee for its services as described in the “Management Fee” section later in this document. The management fee is an annualized rate based on the net asset value of each series of the Fund, accrued daily and paid monthly.

Fixed Administration Fees and Fund Costs

The Manager pays the operating expenses of the Fund, other than Fund Costs, in exchange for the payment by the Fund of a fixed rate administration fee (the “Fixed Administration Fee”) to the Manager with respect to each series of the Fund. The expenses charged to the Fund in respect of the Fixed Administration Fee are disclosed in the Fund’s financial statements. The Fixed Administration Fee is equal to a specified percentage of the net asset value of a series, calculated and paid in the same manner as the management fees for the Fund. Further details about the Fixed Administration Fee can be found in the Fund’s most recent simplified prospectus.

In addition, each series of the Fund is responsible for its proportionate share of certain operating expenses (“Fund Costs”). Further details about Fund Costs can be found in the Fund’s most recent simplified prospectus.

The Manager, at its sole discretion, may waive or absorb a portion of a series’ expenses. These waivers or absorptions may be terminated at any time without notice.

Other Fees

The Manager, or its affiliates, may earn fees and spreads in connection with various services provided to, or transactions with, the Fund, such as banking, custody, brokerage, foreign exchange or derivatives transactions. The Manager, or its affiliates, may earn a foreign exchange spread when unitholders switch between series of funds denominated in different currencies.

Independent Review Committee

The Manager has established an independent review committee (the “IRC”) in accordance with National Instrument 81-107 – Independent Review Committee for Investment Funds (“NI 81-107”) with a mandate to review and provide recommendations or approval, as required, on conflict of interest matters referred to it by the Manager on behalf of the Fund. The IRC is responsible for overseeing the Manager’s decisions in situations where the Manager is faced with any present or perceived conflicts of interest, all in accordance with NI 81-107.

The IRC may also approve certain mergers between the Fund and other funds, and any change of the auditor of the Fund. Subject to any corporate and securities law requirements, no securityholder approval will be obtained in such circumstances, but you will be sent a written notice at least 60 days before the effective date of any such transaction or change of auditor. In certain circumstances, securityholder approval may be required to approve certain mergers.

The IRC has five members, Stephen J. Griggs (Chair), Steven Donald, Simon Hitzig, Heather A. T. Hunter and Jennifer L. Witterick, each of whom is independent of the Manager.

The IRC prepares and files a report to the securityholders each fiscal year that describes the IRC and its activities for securityholders as well as contains a complete list of the standing instructions. These standing instructions enable the Manager to act in a particular conflict of interest matter on a continuing basis provided the Manager complies with its policies and procedures established to address that conflict of interest matter and reports periodically to the IRC on the matter. This report to the securityholders is available on the Manager’s website or, at no cost, by contacting the Manager.

The compensation and other reasonable expenses of the IRC will be paid out of the assets of the Fund as well as out of the assets of the other investment funds for which the IRC may act as the independent review committee. Each member of the IRC receives an annual retainer of \$62,000 (\$77,000 for the Chair), plus expenses for each meeting. The fees and expenses, plus associated legal costs, are allocated among all of the funds managed by the Manager for which the IRC acts as the independent review committee in a manner that is considered by the Manager to be fair and reasonable. The main component of compensation is an annual retainer fee. Prior to November 1, 2021, each IRC member also received a fee for each committee meeting attended. Expenses of the IRC may include premiums for insurance coverage, travel expenses and reasonable out-of-pocket expenses.

The Manager, in respect of the Fund, received the following standing instructions from the IRC with respect to related party transactions:

- Paying brokerage commissions and spreads to a related party for effecting security transactions on an agency and principal basis on behalf of the Fund;

- Purchases or sales of securities of an issuer from or to another investment fund managed by the Manager;
- Investments in the securities of issuers for which a related underwriter acted as an underwriter during the distribution of such securities and the 60-day period following the completion of such distribution;
- Executing foreign exchange transactions with a related party on behalf of the Fund;
- Purchases of securities of a related party;
- Entering into over-the-counter derivatives on behalf of the Fund with a related party;
- Outsourcing products and services to related parties which can be charged to the Fund;
- Acquisition of prohibited securities as defined by securities regulations;
- Trading in mortgages with a related party;
- Entering into a designated broker agreement with a related party; and
- Entering into a prime broker agreement with a related party.

The Manager is required to advise the IRC of any breach of a condition of the standing instructions. The standing instructions require, among other things, that the investment decision in respect to a related party transaction: (a) is made by the Manager free from any influence by an entity related to the Manager and without taking into account any consideration to any associate or affiliate of the Manager; (b) represents the business judgment of the Manager uninfluenced by considerations other than the best interests of the Fund; and (c) is made in compliance with the Manager's written policies and procedures. Transactions made by the Manager under the standing instructions are subsequently reviewed by the IRC to monitor compliance.

The Manager, in respect of the Fund, did not rely on IRC standing instructions regarding related party transactions during the period.

⁽³⁾ The trading expense ratio represents total commissions and other portfolio transaction costs, short borrowing costs and interest on leverage of the Fund and the underlying funds, where applicable, expressed as an annualized percentage of daily average net asset value of the Fund during the period.

⁽⁴⁾ The Fund's portfolio turnover rate indicates how actively the Fund's portfolio advisor manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the period. The higher a fund's portfolio turnover rate in a period, the greater the trading costs payable by the fund in the period, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund.

Management Fees

The management fee is an annualized rate based on the net asset value of each series of the Fund, accrued daily and paid monthly. The management fees cover the costs of managing the Fund, arranging for investment analysis, recommendations and investment decision making for the Fund, arranging for distribution of the Fund, marketing and promotion of the Fund and providing or arranging for other services.

The breakdown of services received in consideration of management fees for each series, as a percentage of the management fees, are as follows:

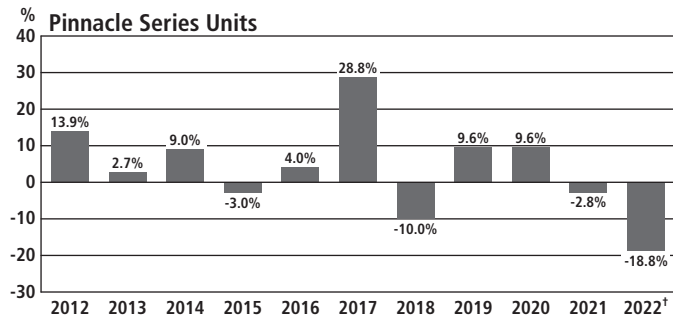

Past Performance

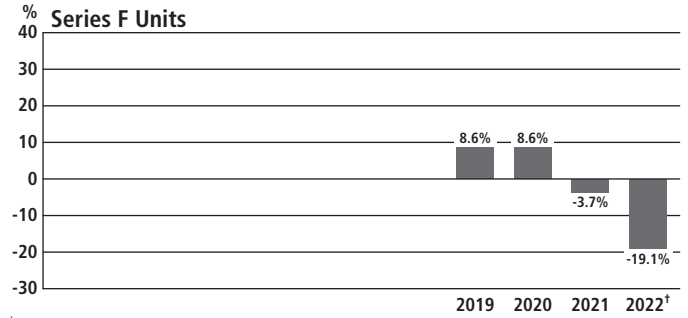

Year-By-Year Returns

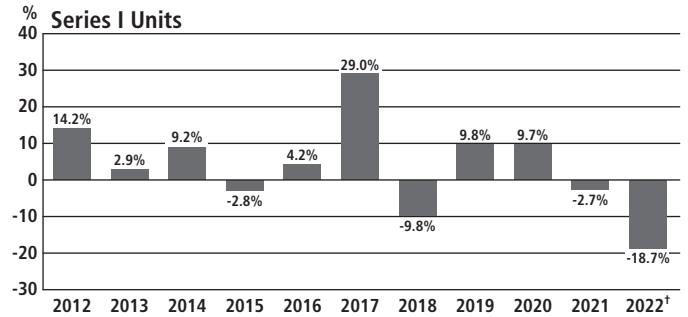

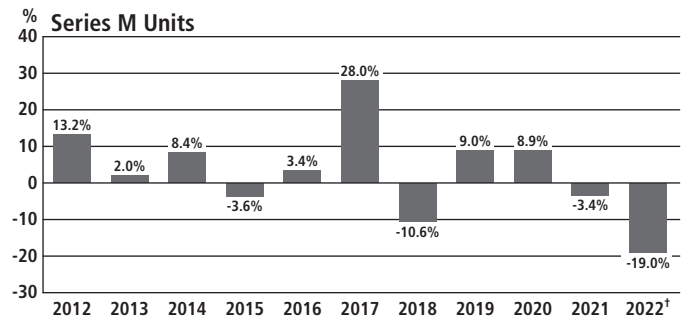

Summary of Investment Portfolio
