1832 Asset Management L.P. is the manager (the "Manager") of the fund. In this document, "we", "us", "our" and the "Manager" refer to 1832 Asset Management L.P. and the "Fund" refers to Scotia Global Growth Fund.

The term "net asset value" or "net asset value per unit" in this document refers to the net asset value determined in accordance with Part 14 of National Instrument 81-106 – Investment Fund Continuous Disclosure ("National Instrument 81-106"); while the term "net assets" or "net assets per unit" refers to total equity or net assets attributable to unitholders of the Fund as determined in accordance with IFRS Accounting Standards.

### Results of Operations

For the six-month period ended at June 30, 2024 (the "period"), the Series A units of the Fund generated a total return of 10.8%. Fund returns are reported net of all management fees and expenses for all series, unlike the returns of the Fund's benchmark, which is based on the performance of an index that does not pay fees or incur expenses. Returns for other series of the Fund will be similar to Series A with any difference in performance being primarily due to different management fees, operating expenses and other expenses that are applicable to that particular series. Please see the "Past Performance" section for the performance of the Fund's other series.

The Fund's broad-based benchmark, the MSCI ACWI (C\$) returned 15.1% during the same period. In accordance with National Instrument 81-106, we have included a comparison to this broad-based index to help you understand the Fund's performance relative to the general performance of the market.

Major equity indices continued their upward trajectory as the U.S. Federal Reserve Board maintained higher interest rates for longer than initially anticipated. Global equity markets continued to be led by stocks in the Information Technology and

Communication Services sectors, with large-capitalization stocks performing particularly well.

European and Japanese equities maintained their positive momentum, benefiting from improved economic conditions. In contrast, China's equity market recovery remained fragile, despite policy efforts to stabilize the property market and boost economic growth.

The Fund underperformed the broad-based benchmark as a result of stock selection in the U.S. and Japan and an overweight allocation to the Consumer Discretionary sector. The underweight position in chip maker NVIDIA Corp. detracted from performance as a result of its large weighting within the index and strong share price performance. The holding remains an important contributor to the Fund's performance on an absolute basis based on the company's ongoing success in artificial intelligence ("AI") and related fields. A position in European low-cost airline Ryanair Holdings PLC was another detractor from the Fund's performance. The company faced challenges in recent months, including delays in the delivery of 20 new aircraft and management's forecast indicating a potential weakening in summer ticket prices. Despite these challenges, the company continued to make good operational progress. A holding in B3 SA – Brasil Bolsa Balcao detracted from the Fund's performance. The company's share price was weak because of lower average daily trading volumes and increasing investments. The latter was a reaction to interest rate increases and thus management looked to invest in other sources of income.

Stock selection in the Communication Services sector contributed strongly to relative performance. The largest individual contributors to performance were holdings in Meta Platforms Inc., Taiwan Semiconductor Manufacturing Co. Ltd. ("TSMC") and Spotify Technology SA. Meta Platforms continues to adapt quickly and pivot to profitability. It has used AI tools to improve advertising quality and target more effectively, leading to increased ad impressions and revenue per ad. Earlier in 2024, it posted its best sales growth in more than two years, including better-than-expected revenues and an increase in daily active users across its family of apps. TSMC's share price reacted positively to the announcement made by NVIDIA's CEO Jensen Huang that it is accelerating its product upgrade cycle from two years to one. As its second-largest customer, NVIDIA's news propelled TSMC's share price upwards. Spotify Technology's share price performance was strong due to a strategic shift from prioritizing growth at all costs to coupling focused growth with rising margins, demonstrated by an increase in its gross and operating margins in the first quarter of 2024.

The Fund's Health Care sector exposure was increased with the addition of new holdings in Novo Nordisk AS and UnitedHealth Group Inc. Other new Fund holdings included Brunswick Corp., The Walt Disney Company and AutoZone Inc. based on their attractive valuations and underappreciated growth drivers. Exposure to the broader semiconductor value chain was increased as demand strengthens from areas such as data centres and AI. Additions were made to TSMC, Samsung Electronics Co. Ltd., Texas Instruments Inc. and NVIDIA. Additions were also made to companies that have adapted to the new macroeconomic

environment and seen a reacceleration in growth, including Spotify Technology, Block Inc., Adyen NV, Coupang Inc. and Netflix Inc.

Holdings in Adidas AG, Alibaba Group Holding Ltd., Broadridge Financial Solutions Inc., The Charles Schwab Corp., The Estée Lauder Companies Inc., Exact Sciences Corp., The Howard Hughes Corp., Novocure Ltd., Prudential PLC, Snowflake Inc., Tesla Inc. and Wayfair Inc. were eliminated. Several high-quality companies were trimmed after strong share price performance. These holdings included CRH PLC, Eaton Corp. PLC, Entegris Inc., Martin Marietta Materials Inc., Meta Platforms Inc., Moody's Corp. and S&P Global Inc. The Fund's position in Alphabet Inc. was trimmed in light of the potential shift in the competitive landscape of the global search engine market due to the rapid advancement in AI technologies.

The Fund's net asset value decreased to \$1,625.6 million at June 30, 2024, from \$1,842.9 million at December 31, 2023. This change was composed of net redemptions of \$416.3 million, cash distributions of \$20,027 and investment performance of \$199.0 million. The investment performance of the Fund includes income and expenses which vary year over year. The Fund's income and expenses changed compared to the previous year mainly as a result of fluctuations in average net assets, portfolio activity and changes in the Fund's income earning investments.

Certain series of the Fund, as applicable, may make distributions at a rate determined by the Manager from time to time. If the aggregate amount of distributions in such series exceeds the portion of net income and net realized capital gains allocated to such series, the excess will constitute a return of capital. The Manager does not believe that the return of capital distributions made by such series of the Fund have a meaningful impact on the Fund's ability to implement its investment strategy or to fulfill its investment objective.

## Recent Developments

There have been no recent developments that have affected, or are likely to materially affect the Fund.

## Related Party Transactions

The Manager is a wholly owned subsidiary of The Bank of Nova Scotia ("Scotiabank"). Scotiabank also owns, directly or indirectly, 100% of Scotia Securities Inc., a mutual fund dealer, and Scotia Capital Inc. (which includes ScotiaMcLeod and Scotia iTRADE), an investment dealer.

The Manager, on behalf of the Fund, may enter into transactions or arrangements with other members of Scotiabank or certain other companies that are related or connected to the Manager (each a "related party"). All transactions between the Fund and the related parties are in the normal course of business and are carried out at arm's length terms.

The purpose of this section is to provide a brief description of any transaction involving the Fund and a related party.

### **Management Fees**

The Manager is responsible for the day-to-day management and operations of the Fund. Certain series of the Fund pay the Manager a management fee for its services as described in the “Management Fee” section later in this document. The management fee is an annualized rate based on the net asset value of each series of the Fund, accrued daily and paid monthly.

### **Fixed Administration Fees and Fund Costs**

The Manager pays the operating expenses of the Fund, other than Fund Costs, in exchange for the payment by the Fund of a fixed rate administration fee (the “Fixed Administration Fee”) to the Manager with respect to each series of the Fund, other than Series F. The expenses charged to the Fund in respect of the Fixed Administration Fee are disclosed in the Fund’s financial statements. The Fixed Administration Fee is equal to a specified percentage of the net asset value of a series, calculated and paid in the same manner as the management fees for the Fund. Further details about the Administration Fee can be found in the Fund’s most recent simplified prospectus.

Where applicable, the Series F of the Fund paid its proportionate share of the Fund’s operating expenses that are common to all Series throughout the period.

In addition, each series of the Fund is responsible for its proportionate share of certain operating expenses (“Fund Costs”). Further details about Fund Costs can be found in the Fund’s most recent simplified prospectus.

The Manager, at its sole discretion, may waive or absorb a portion of a series’ expenses, Fixed Administration Fee, operating expenses or Fund Costs. These waivers or absorptions may be terminated at any time without notice.

### **Distribution Services**

Certain registered dealers through which units of the Fund are distributed are related parties to the Fund and the Manager. The Manager may pay a trailing commission, which is negotiated with dealers, to dealers for their financial advisors in respect of the assets of their clients invested in securities of the Fund. The Manager, during the period, could also pay trailing commissions to dealers for securities purchased or held through discount brokerage accounts.

### **Other Fees**

The Manager, or its affiliates, may earn fees and spreads in connection with various services provided to, or transactions with, the Fund, such as banking, custody, brokerage, foreign exchange or derivatives transactions. The Manager, or its affiliates, may earn a foreign exchange spread when unitholders switch between series of funds denominated in different currencies.

### **Independent Review Committee**

The Manager has established an independent review committee (the “IRC”) in accordance with National Instrument 81-107 – Independent Review Committee for Investment Funds

(“NI 81-107”) with a mandate to review and provide recommendations or approval, as required, on conflict of interest matters referred to it by the Manager on behalf of the Fund. The IRC is responsible for overseeing the Manager’s decisions in situations where the Manager is faced with any present or perceived conflicts of interest, all in accordance with NI 81-107.

The IRC may also approve certain mergers between the Fund and other funds, and any change of the auditor of the Fund. Subject to any corporate and securities law requirements, no securityholder approval will be obtained in such circumstances, but you will be sent a written notice at least 60 days before the effective date of any such transaction or change of auditor. In certain circumstances, securityholder approval may be required to approve certain mergers.

The IRC has four members, Stephen J. Griggs (Chair), Steven Donald, Heather A. T. Hunter and Jennifer L. Witterick, each of whom is independent of the Manager.

The IRC prepares and files a report to the securityholders each fiscal year that describes the IRC and its activities for securityholders as well as contains a complete list of the standing instructions. These standing instructions enable the Manager to act in a particular conflict of interest matter on a continuing basis provided the Manager complies with its policies and procedures established to address that conflict of interest matter and reports periodically to the IRC on the matter. This report to the securityholders is available on the Manager’s website or, at no cost, by contacting the Manager.

The compensation and other reasonable expenses of the IRC will be paid out of the assets of the Fund as well as out of the assets of the other investment funds for which the IRC may act as the independent review committee. Each member of the IRC receives an annual retainer of \$62,000 (\$77,000 for the Chair), plus expenses for each meeting. The fees and expenses, plus associated legal costs, are allocated among all of the funds managed by the Manager for which the IRC acts as the independent review committee in a manner that is considered by the Manager to be fair and reasonable. The main component of compensation is an annual retainer fee. Expenses of the IRC may include premiums for insurance coverage, travel expenses and reasonable out-of-pocket expenses.

The Manager, in respect of the Fund, received the following standing instructions from the IRC with respect to related party transactions:

- Paying brokerage commissions and spreads to a related party for effecting security transactions on an agency and principal basis on behalf of the Fund;
- Purchases or sales of securities of an issuer from or to another investment fund managed by the Manager;
- Investments in the securities of issuers for which a related underwriter acted as an underwriter during the distribution of such securities and the 60-day period following the completion of such distribution;
- Executing foreign exchange transactions with a related party on behalf of the Fund;

- Purchases of securities of a related party;
- Entering into over-the-counter derivatives on behalf of the Fund with a related party;
- Outsourcing products and services to related parties which can be charged to the Fund;
- Acquisition of prohibited securities as defined by securities regulations;
- Trading in mortgages with a related party;
- Entering into a designated broker agreement with a related party; and
- Entering into a prime broker agreement with a related party.

The Manager is required to advise the IRC of any breach of a condition of the standing instructions. The standing instructions require, among other things, that the investment decision in respect to a related party transaction: (a) is made by the Manager free from any influence by an entity related to the Manager and without taking into account any consideration to any associate or affiliate of the Manager; (b) represents the business judgment of the Manager uninfluenced by considerations other than the best interests of the Fund; and (c) is made in compliance with the Manager's written policies and procedures. Transactions made by the Manager under the standing instructions are subsequently reviewed by the IRC to monitor compliance.

The Manager, in respect of the Fund, did not rely on IRC standing instructions regarding related party transactions during the period.

(3) The trading expense ratio represents total commissions and other portfolio transaction costs, short borrowing costs and interest on leverage of the Fund and the underlying funds, where applicable, expressed as an annualized percentage of daily average net asset value of the Fund during the period.

(4) The Fund's portfolio turnover rate indicates how actively the Fund's portfolio advisor manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the period. The higher a fund's portfolio turnover rate in a period, the greater the trading costs payable by the fund in the period, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund.

**Management Fees**

The management fee is an annualized rate based on the net asset value of each series of the Fund, accrued daily and paid monthly. The management fees cover the costs of managing the Fund, arranging for investment analysis, recommendations and investment decision making for the Fund, arranging for distribution of the Fund, marketing and promotion of the Fund and providing or arranging for other services.

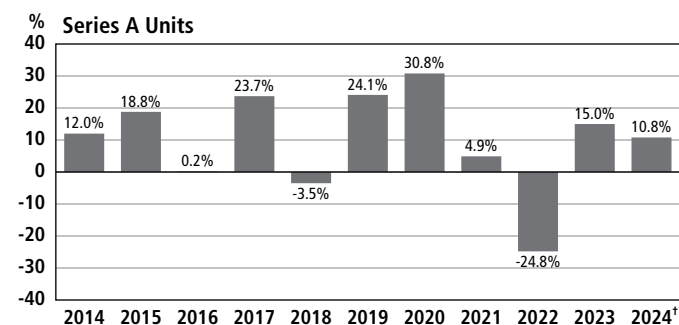

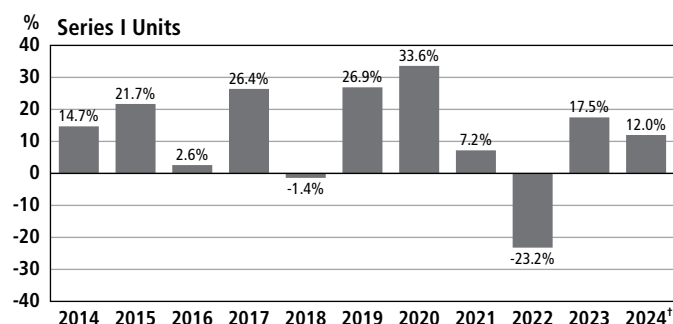
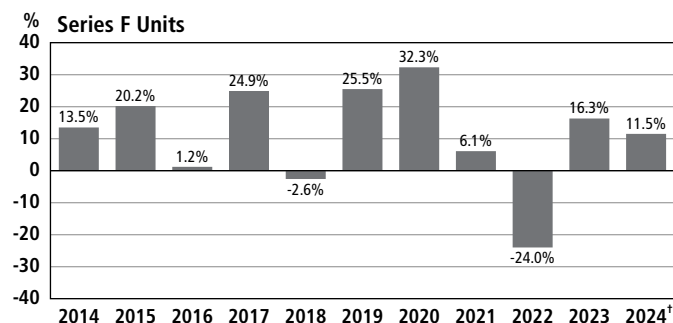
