The term "net asset value" or "net asset value per unit" in this document refers to the net asset value determined in accordance with Part 14 of National Instrument 81-106 – Investment Fund Continuous Disclosure ("National Instrument 81-106"); while the term "net assets" or "net assets per unit" refers to total equity or net assets attributable to unitholders of the Fund as determined in accordance with IFRS Accounting Standards.

Results of Operations

For the six-month period ended at June 30, 2024 (the "period"), the Series A units of the Fund generated a total return of 3.5%. Fund returns are reported net of all management fees and expenses for all series, unlike the returns of the Fund's benchmark, which is based on the performance of an index that does not pay fees or incur expenses. Returns for other series of the Fund will be similar to Series A with any difference in performance being primarily due to different management fees, operating expenses and other expenses that are applicable to that particular series. Please see the "Past Performance" section for the performance of the Fund's other series.

To achieve its long-term asset allocation mandate, the Fund invested directly in fund(s) managed by the Manager or by third party investment managers ("Underlying Fund(s)"). As a result the following commentary on investment portfolio activity relates to the Underlying Fund(s). Commentary on income, expenses and unitholder activity relate to the Fund.

The Fund's broad-based benchmark, the MSCI World Index (C\$) returned 15.5% during the same period. In accordance with National Instrument 81-106, we have included a comparison to this broad-based index to help you understand the Fund's

performance relative to the general performance of the market, but caution that the Fund's mandate may be significantly different from the indices shown.

The Fund's blended benchmark, 50% FTSE Canada Universe Bond Index and 50% MSCI World Index (C\$) returned 7.4% during the same period. We have included this comparison, which more closely reflects the market sectors and/or asset classes in which the Fund invests, to provide a more useful comparative to the performance of the Fund.

The Fund underperformed the broad-based benchmark.

Consistent with the Fund's investment objectives, the portfolio advisor assesses to have a lower carbon intensity than that of the broad market. To assist the portfolio advisor in measuring the relative carbon output of the Fund's investments, the weighted average carbon intensity (a carbon footprint analysis based on the measure of the volume of carbon emissions per dollar of sales generated by underlying companies, normalized by the weight of those securities in a portfolio) will be calculated for both the Fund and the relevant broad market index (a generally recognized broad-based-blended index that measures both equity performance of global developed markets, currently the MSCI World Index and fixed income performance of Canadian fixed income markets, currently the FTSE Canada Universe Bond Index).

As of June 30, 2024, the Carbon Intensity for Scotia Low Carbon Global Balanced Fund, as measured as Tonnes CO₂e / \$M Sales, is 28.6 versus 113.5 for the broad-based blended index, 50% – FTSE Canada Universe Bond Index and 50% – MSCI World Index (C\$). The Fund's Carbon Intensity is 75% lower than the Index.

Carbon intensity will be assessed in metric tonnes and includes both Scope 1 and 2 carbon dioxide equivalent (CO₂e) emissions per million U.S. dollars in revenue generated by a business, where Scope 1 emissions refer to direct greenhouse gas (e.g. CO₂) emissions from company operations; Scope 2 emissions refer to emissions from purchased electricity.

The carbon intensity of the Fund's investments will be actively managed by applying investment restrictions to exclude investments in companies included in the energy sector of a broad market index, with the exception of renewable energy entities as defined by the portfolio advisor and non-energy sector companies that own operating businesses with proven material thermal coal, oil or gas reserves. Businesses that have a significant amount of value attributable directly to the extraction and production of fossil fuels, or indirectly through transportation, distribution, equipment and services and with significant exposure to power generation from fossil fuels, are excluded from investments in this Fund. Exceptions may be made where a company has a clear strategy to meaningfully increase the percentage of renewables.

Several factors contributed to the Fund's underperformance to the benchmark: stock selection and our underweight position in Information Technology sector impacted relative performance, but the more significant headwind was our absence of NVIDIA, which benefited from an Artificial-Intelligence (AI) lift, contributed to the Fund's underperformance. Our absence from NVIDIA alone is responsible for almost half of the underperformance in the period.

Equities in general powered to new highs against a backdrop of good corporate earnings and supportive economic data, along with the U.S. Federal Reserve and European Central Bank's (ECB) hints of interest rate reductions to come this year. While not necessarily a surprise to markets, it was notable in the context of already firm economic momentum, particularly in the United States and already strong performance in equities.

Japanese markets were strongest of major markets globally, as exporters and financials rallied strongly. U.S. markets were also robust, led by a broad group of cyclical and, in particular, AI-related equities. European markets were also firm, with broad strength in both technology and financials. Canadian and emerging market equity indices were positive, although lagged other markets.

From a sector standpoint, it was Technology that once again led the way globally. Semiconductor stocks notably rallied on continued optimism surrounding the use of AI-related technologies and the chips that will be required to power these applications. The Financials sector was also a leader in many geographies, due to expanding profitability coupled with expected relief for customers on interest rates moving forward. Conversely, more defensive sectors such as Consumer Staples, Utilities and Real Estate were amongst the lagging sectors in a strong market.

Global economic activity presented a mixed picture during the second quarter. In the eurozone, growth stalled, with manufacturing PMIs at 45.6 in June. Inflation remained sticky as core inflation ticked up to 2.9% in May from 2.7% in April, while services inflation increased to 4.1% from 4.0%. Prior to the May readings, inflation had been trending downward toward the ECB target. In the U.K., PMIs continue to soften to 51.7 in June from 53.0 in May, illustrating a slowing pace of economic growth at a time when U.K. inflation returned to the 2.0% target for the first time in three years. U.K. services-related inflation continues to be elevated at 5.7%.

Given its importance, we would be remiss to not share our current thinking on NVIDIA and its meteoric rise. Ultimately, we think that NVIDIA's success is closely tied to the success of its main customers, though short-term divergences driven by product and investment cycles are possible. While we consider NVIDIA a viable investment given its strong management and dominant IP in artificial intelligence chips – which encompasses both hardware and software – we underestimated how quickly those chips would be adopted. NVIDIA's AI business is on track to surpass the entire traditional computer chip market and peers like Intel, Qualcomm and AMD. At present, we believe it will be difficult for NVIDIA to sustain its present growth and sky-high margins. We see the potential for a near-term correction, as the rapid expansion of AI infrastructure may have exceeded end customers' ability to derive appropriate economic benefits from the technology. Today's valuation offers minimal downside protection and while our tech giants would also be affected by such an outcome, their more diversified operations would likely provide an offset to any AI-related weakness.

On the fixed side, the 10-year Government of Canada yield trended higher, peaking in April, before drifting lower and ending at 3.5% for the period. The Bank of Canada (BoC) became the

first of the G7 countries to begin easing as they announced a 25 basis point cut in early June; this was the first rate cut by the BoC in four years. Within the U.S., the 10-year Treasury yield similarly trended upwards finishing June at 4.4%, though the Federal Reserve held its policy rate steady during the period. Investment grade and high yield credit spreads, as measured by ICE BofA Canadian and U.S. corporate indices OAS (Option-Adjusted Spread) narrowed during the period, widening briefly at the end of June.

During the first quarter, as corporate spreads tightened, the Fund selectively took the opportunity to reduce its holdings in Bell Canada Inc. and Hydro One Inc. and exited its holdings in Nestlé Inc. The portfolio also added to its holdings in various provincial government bonds in the belly of the curve.

In the second quarter, we did take advantage of the tighter spreads by reducing our risk allocation to corporate bonds. With valuations elevated, default rates rising and rating downgrades also rising, we expect our cautiousness to be rewarded with more attractive opportunities in the future. The Fund's performance benefited from its selection and allocation in the financial sector and select utility holdings.

We continue to observe a mixed backdrop for equities. Global economic growth remains positive, corporate earnings are healthy and inflationary pressures look to be subsiding. However, we are also seeing increasing signs of a weakening consumer market and heightened geopolitical risk. Valuations in many equity markets are also elevated relative to history. We believe businesses that meet our strict criteria are particularly well-positioned in this environment, supporting long-term investment returns.

The Fund's net asset value increased to \$18.8 million at June 30, 2024, from \$16.6 million at December 31, 2023. This change was composed of net sales of \$1.7 million and investment performance of \$0.5 million. The investment performance of the Fund includes income and expenses which vary year over year. The Fund's income and expenses changed compared to the previous year mainly as a result of fluctuations in average net assets, portfolio activity and changes in the Fund's income earning investments.

Certain series of the Fund, as applicable, may make distributions at a rate determined by the Manager from time to time. If the aggregate amount of distributions in such series exceeds the portion of net income and net realized capital gains allocated to such series, the excess will constitute a return of capital. The Manager does not believe that the return of capital distributions made by such series of the Fund have a meaningful impact on the Fund's ability to implement its investment strategy or to fulfill its investment objective.

Recent Developments

There have been no recent developments that have affected, or are likely to materially affect the Fund.

Related Party Transactions

The Manager is a wholly owned subsidiary of The Bank of Nova Scotia ("Scotiabank"). Scotiabank also owns, directly or indirectly,

100% of Scotia Securities Inc., a mutual fund dealer, and Scotia Capital Inc. (which includes ScotiaMcLeod and Scotia iTRADE), an investment dealer.

The Manager, on behalf of the Fund, may enter into transactions or arrangements with other members of Scotiabank or certain other companies that are related or connected to the Manager (each a "related party"). All transactions between the Fund and the related parties are in the normal course of business and are carried out at arm's length terms.

The purpose of this section is to provide a brief description of any transaction involving the Fund and a related party.

Management Fees

The Manager is responsible for the day-to-day management and operations of the Fund. Certain series of the Fund pay the Manager a management fee for its services as described in the "Management Fee" section later in this document. The management fee is an annualized rate based on the net asset value of each series of the Fund, accrued daily and paid monthly.

Fixed Administration Fees and Fund Costs

The Manager pays the operating expenses of the Fund, other than Fund Costs, in exchange for the payment by the Fund of a fixed rate administration fee (the "Fixed Administration Fee") to the Manager with respect to each series of the Fund. The expenses charged to the Fund in respect of the Fixed Administration Fee are disclosed in the Fund's financial statements. The Fixed Administration Fee is equal to a specified percentage of the net asset value of a series, calculated and paid in the same manner as the management fees for the Fund. Further details about the Fixed Administration Fee can be found in the Fund's most recent simplified prospectus.

In addition, each series of the Fund is responsible for its proportionate share of certain operating expenses ("Fund Costs"). Further details about Fund Costs can be found in the Fund's most recent simplified prospectus.

The Manager, at its sole discretion, may waive or absorb a portion of a series' expenses. These waivers or absorptions may be terminated at any time without notice.

Custodial Services

Scotiabank, as the custodian of the Fund, earns a fee for providing custody and related services. The custodian holds the cash and investments of the Fund in safekeeping to ensure that they are used only for the benefit of the investors of the Fund. The custodian fee is paid by the Manager, in exchange for the Fixed Administration Fee received from the Fund.

The Fund has received approval from the Independent Review Committee to invest the Fund's overnight cash with Scotiabank with interest paid by Scotiabank to the Fund, based on prevailing market rates.

Distribution Services

Certain registered dealers through which units of the Fund are distributed are related parties to the Fund and the Manager. The

Manager may pay a trailing commission, which is negotiated with dealers, to dealers for their financial advisors in respect of the assets of their clients invested in securities of the Fund. The Manager, during the period, could also pay trailing commissions to dealers for securities purchased or held through discount brokerage accounts.

Related Sub-Advisor

The Fund is sub-advised by Jarislowsky Fraser Limited, a related party to the fund. The Manager may pay a fee, which is negotiated with the sub-advisor, to the sub-advisor in respect of the investment advisory services provided to the Fund.

Other Fees

The Manager, or its affiliates, may earn fees and spreads in connection with various services provided to, or transactions with, the Fund, such as banking, custody, brokerage, foreign exchange or derivatives transactions. The Manager, or its affiliates, may earn a foreign exchange spread when unitholders switch between series of funds denominated in different currencies.

Independent Review Committee

The Manager has established an independent review committee (the "IRC") in accordance with National Instrument 81-107 – Independent Review Committee for Investment Funds ("NI 81-107") with a mandate to review and provide recommendations or approval, as required, on conflict of interest matters referred to it by the Manager on behalf of the Fund. The IRC is responsible for overseeing the Manager's decisions in situations where the Manager is faced with any present or perceived conflicts of interest, all in accordance with NI 81-107.

The IRC may also approve certain mergers between the Fund and other funds, and any change of the auditor of the Fund. Subject to any corporate and securities law requirements, no securityholder approval will be obtained in such circumstances, but you will be sent a written notice at least 60 days before the effective date of any such transaction or change of auditor. In certain circumstances, securityholder approval may be required to approve certain mergers.

The IRC has four members, Stephen J. Griggs (Chair), Steven Donald, Heather A. T. Hunter and Jennifer L. Witterick, each of whom is independent of the Manager.

The IRC prepares and files a report to the securityholders each fiscal year that describes the IRC and its activities for securityholders as well as contains a complete list of the standing instructions. These standing instructions enable the Manager to act in a particular conflict of interest matter on a continuing basis provided the Manager complies with its policies and procedures established to address that conflict of interest matter and reports periodically to the IRC on the matter. This report to the securityholders is available on the Manager's website or, at no cost, by contacting the Manager.

The compensation and other reasonable expenses of the IRC will be paid out of the assets of the Fund as well as out of the assets of the other investment funds for which the IRC may act as the

independent review committee. Each member of the IRC receives an annual retainer of \$62,000 (\$77,000 for the Chair), plus expenses for each meeting. The fees and expenses, plus associated legal costs, are allocated among all of the funds managed by the Manager for which the IRC acts as the independent review committee in a manner that is considered by the Manager to be fair and reasonable. The main component of compensation is an annual retainer fee. Expenses of the IRC may include premiums for insurance coverage, travel expenses and reasonable out-of-pocket expenses.

The Manager, in respect of the Fund, received the following standing instructions from the IRC with respect to related party transactions:

- Paying brokerage commissions and spreads to a related party for effecting security transactions on an agency and principal basis on behalf of the Fund;
- Purchases or sales of securities of an issuer from or to another investment fund managed by the Manager;
- Investments in the securities of issuers for which a related underwriter acted as an underwriter during the distribution of such securities and the 60-day period following the completion of such distribution;
- Executing foreign exchange transactions with a related party on behalf of the Fund;
- Purchases of securities of a related party;
- Entering into over-the-counter derivatives on behalf of the Fund with a related party;
- Outsourcing products and services to related parties which can be charged to the Fund;
- Acquisition of prohibited securities as defined by securities regulations;
- Trading in mortgages with a related party;
- Entering into a designated broker agreement with a related party; and
- Entering into a prime broker agreement with a related party.

The Manager is required to advise the IRC of any breach of a condition of the standing instructions. The standing instructions require, among other things, that the investment decision in respect to a related party transaction: (a) is made by the Manager free from any influence by an entity related to the Manager and without taking into account any consideration to any associate or affiliate of the Manager; (b) represents the business judgment of the Manager uninfluenced by considerations other than the best interests of the Fund; and (c) is made in compliance with the Manager's written policies and procedures. Transactions made by the Manager under the standing instructions are subsequently reviewed by the IRC to monitor compliance.

The Manager, in respect of the Fund, did not rely on IRC standing instructions regarding related party transactions during the period.

(2) The management expense ratio is based on the total expenses (including sales tax, and excluding commissions and other portfolio transaction costs) of each series of the Fund and a proportional share of underlying funds' expenses (mutual funds, ETFs and closed-end funds), where applicable, for the stated period and is expressed as an annualized percentage of daily average net asset value during the period.

(3) The trading expense ratio represents total commissions and other portfolio transaction costs, short borrowing costs and interest on leverage of the Fund and the underlying funds, where applicable, expressed as an annualized percentage of daily average net asset value of the Fund during the period.

(4) The Fund's portfolio turnover rate indicates how actively the Fund's portfolio advisor manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the period. The higher a fund's portfolio turnover rate in a period, the greater the trading costs payable by the fund in the period, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund.

Management Fees

The management fee is an annualized rate based on the net asset value of each series of the Fund, accrued daily and paid monthly. The management fees cover the costs of managing the Fund, arranging for investment analysis, recommendations and investment decision making for the Fund, arranging for distribution of the Fund, marketing and promotion of the Fund and providing or arranging for other services.

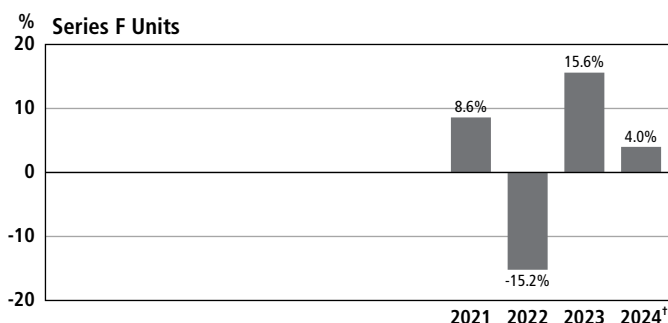
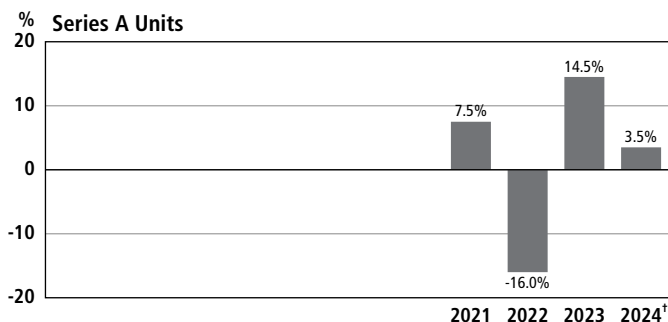
